6	SECTION 1. Subchapter E, Chapter 521, Transportation Code,
7	is amended by adding Section 521.1025 to read as follows:
8	Sec. 521.1025. DESIGNATOR ON PERSONAL IDENTIFICATION
9	CERTIFICATE ISSUED TO EMERGENCY MEDICAL SERVICES PERSONNEL. (a)
10	In this section, "emergency medical services personnel" has the
11	meaning assigned by Section 773.003, Health and Safety Code.
12	(b) The department shall include the designation "EMERGENCY
13	MEDICAL" on a personal identification certificate issued to
14	emergency medical services personnel in an available space either
15	on the face of the personal identification certificate or on the
16	reverse side of the personal identification certificate if the
17	<pre>emergency medical services personnel:</pre>
18	(1) requests the designation; and
19	(2) provides proof sufficient to the department that
20	the person is certified as emergency medical services personnel
21	under Chapter 773, Health and Safety Code.
22	(c) A person who renews a personal identification

sufficient to the department that the person is certified as

- 11 Sec. 521.1236. DESIGNATOR ON LICENSE ISSUED TO EMERGENCY
- 12 MEDICAL SERVICES PERSONNEL. (a) In this section, "emergency
- 13 medical services personnel" has the meaning assigned by Section
- 14 773.003, Health and Safety Code.
- 15 (b) The department shall include the designation "EMERGENCY
- 16 MEDICAL" on a driver's license issued to emergency medical services
- 17 personnel in an available space either on the face of the driver's
- 18 <u>license or on the reverse side of the driver's license if the</u>
- 19 emergency medical services personnel:
- 20 (1) requests the designation; and
- 21 (2) provides proof sufficient to the department that
- 22 the person is certified as emergency medical services personnel
- 23 under Chapter 773, Health and Safety Code.
- (c) A person who renews a driver's license described by this
- 25 section shall provide proof sufficient to the department that the
- 26 person is certified as emergency medical services personnel under
- 27 Chapter 773, Health and Safety Code.

- (d) A person who holds a driver's license described by this
 section shall surrender the license to the department in a manner
 provided by department rule if the person's certification as
 emergency medical services personnel expires or is revoked or
 suspended as provided by Chapter 773, Health and Safety Code.
- SECTION 3. As soon as practicable after the effective date of this Act, the Department of Public Safety of the State of Texas shall adopt the rules required by Sections 521.1025 and 521.1236, Transportation Code, as added by this Act.
- 10 SECTION 4. This Act takes effect September 1, 2019.
