## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the Texas Olive Oil Industry Advisory Board. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Title 3, Agriculture Code, is amended by adding 4 5 Chapter 50D to read as follows: CHAPTER 50D. TEXAS OLIVE OIL INDUSTRY ADVISORY BOARD 6 Sec. 50D.001. DEFINITION. In this chapter, "board" means 7 the Texas Olive Oil Industry Advisory Board. 8 9 Sec. 50D.002. BOARD. (a) The board is composed of the following nine members appointed by the commissioner: 10 11 (1) five members who are olive growers, one of whom 12 represents each of the five established olive-growing regions of the state as determined by the commissioner; 13 14 (2) one representative of infrastructure who is engaged in harvesting, milling, or agritourism; 15 16 (3) one researcher or educator who is employed by an institution of higher education, as defined by Section 61.003, 17 Education Code; 18 19 (4) one representative from the Texas A&M AgriLife Extension Service; and 20 21 (5) one representative from the department. 22 (b) The board shall elect a presiding officer from among its 23 members. 24 (c) Members of the board serve staggered six-year terms,

1	with the terms of three members expiring on February 1 of each
2	odd-numbered year. Members may be reappointed at the end of a term.
3	(d) Chapter 2110, Government Code, does not apply to the
4	size, composition, or duration of the board.
5	(e) Service on the board by a state officer or employee is an
6	additional duty of the member's office or employment. Members of
7	the board are not entitled to compensation or reimbursement of
8	expenses.
9	(f) The board may accept gifts and grants from any source to
10	be used to carry out a function of the board.
11	Sec. 50D.003. DUTIES. The board shall:
12	(1) assist the department in:
13	(A) assessing the state of the olive and olive
14	oil industry in this state;
15	(B) developing recommendations to the
16	commissioner and the legislature to promote and expand the olive
17	and olive oil industry in this state;
18	(C) identifying and obtaining grants and gifts to
19	promote and expand the olive and olive oil industry in this state;
20	and
21	(D) developing a long-term vision and marketable
22	identity for the olive and olive oil industry in this state that
23	take into consideration future industry development, funding,
24	research, educational programming, risk management, and marketing;
25	and
26	(2) review and provide guidance on rules impacting the
27	olive and olive oil industry in this state.

Sec. 50D.004. MEETINGS. The board shall meet twice each year and may meet at other times considered necessary by the commissioner.

<u>Sec. 50D.005. STAFF.</u> The board is administratively
<u>attached to the department.</u> The department shall provide the board
with the staff necessary to carry out the board's duties under this
<u>chapter.</u>

8 SECTION 2. As soon as practicable after the effective date 9 of this Act, the commissioner of agriculture shall appoint the 10 members of the Texas Olive Oil Industry Advisory Board as provided 11 by Chapter 50D, Agriculture Code, as added by this Act.

12 SECTION 3. This Act takes effect immediately if it receives 13 a vote of two-thirds of all the members elected to each house, as 14 provided by Section 39, Article III, Texas Constitution. If this 15 Act does not receive the vote necessary for immediate effect, this 16 Act takes effect September 1, 2019.
