5	SECTION 1. Section 14, Chapter 273, Acts of the 55th			
6	Legislature, Regular Session, 1957, is amended to read as follows:			
7	Sec. 14. <u>(a)</u> The Board of Directors of the Authority <u>is</u>			
8	composed [shall be comprised] of eight persons who serve staggered,			
9	four-year terms.			
10	(b) [Immediately after this Act becomes effective, the			
11	following named persons shall be the directors of the Authority and			
12	shall constitute the Board of Directors of said Authority:			
13	[W. M. Evetts, Route 1, Moody, Texas;			
14	[David Haggard, Route 4, Oenaville, Texas;			
15	[J. W. Holmes, Route 2, Rogers, Texas;			
16	[Buster Griffin, Buckholts, Texas;			
17	[Jim Reddin, Troy, Texas;			
18	[Bartle Crenan, Cameron, Texas;			
19	[Frank Maruna, Temple, Texas; and			
20	[A. A. Stavinoha, Temple, Texas.			
21	[The Board of Directors herein appointed shall serve			
22	until their successors have been duly elected and qualified. The			
23	first four directors named above shall serve until the second			
21	Tuesday in January 1958 and the following four directors shall

- 1 serve until the second Tuesday in January, 1959. An election for
- 2 directors shall be held on the uniform election date [second
- 3 Tuesday in November [January] of each odd-numbered year [and as
- 4 herein provided. Four directors shall be elected in each even
- 5 numbered year and four in each odd numbered year].
- 6 <u>(c)</u> The directors of the Authority or of any subordinate
- 7 district shall be landowners within the Authority and reside within
- 8 Bell, Falls, Milam or McLennan Counties, and shall retain such
- 9 status during their tenure in office or vacate such office.
- 10 SECTION 2. (a) A director of the Elm Creek Watershed
- 11 Authority elected in May 2019 shall serve until the director's
- 12 successor has qualified following the directors' election held on
- 13 the uniform election date in November 2023. A director elected on
- 14 the uniform election date in November 2023 serves a four-year term.
- 15 (b) A director of the Elm Creek Watershed Authority elected
- 16 in 2018 shall serve until the director's successor has qualified
- 17 following the directors' election held on the uniform election date
- 18 in November 2021. A director elected to succeed that director
- 19 serves a four-year term.
- 20 (c) This section expires September 1, 2024.
- 21 SECTION 3. (a) The legal notice of the intention to
- 22 introduce this Act, setting forth the general substance of this
- 23 Act, has been published as provided by law, and the notice and a
- 24 copy of this Act have been furnished to all persons, agencies,
- 25 officials, or entities to which they are required to be furnished
- 26 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 27 Government Code.

- 1 (b) The governor, one of the required recipients, has
- 2 submitted the notice and Act to the Texas Commission on
- 3 Environmental Quality.
- 4 (c) The Texas Commission on Environmental Quality has filed
- 5 its recommendations relating to this Act with the governor, the
- 6 lieutenant governor, and the speaker of the house of
- 7 representatives within the required time.
- 8 (d) All requirements of the constitution and laws of this
- 9 state and the rules and procedures of the legislature with respect
- 10 to the notice, introduction, and passage of this Act are fulfilled
- 11 and accomplished.
- 12 SECTION 4. This Act takes effect September 1, 2019.
