4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter F, Chapter 223, Transportation Code,
6	is amended by adding Section 223.2475 to read as follows:
7	Sec. 223.2475. CHANGES TO DESIGN-BUILD TEAM. (a) A
8	design-build contractor selected for a contract may not make
9	changes to companies or entities identified as part of the
10	design-build team in a response to a request for proposals unless an
11	<pre>identified company or entity:</pre>
12	(1) is no longer in business, is unable to fulfill its
13	legal, financial, or business obligations, or can no longer meet
14	the terms of the teaming agreement proposed for the project with the
15	design-build contractor;
16	(2) voluntarily removes itself from the team;
17	(3) fails to provide a sufficient number of qualified
18	personnel to fulfill the duties identified during the proposal
19	stage; or
20	(4) fails to negotiate in good faith in a timely manner
21	in accordance with provisions established in the teaming agreement
22	proposed for the project.
23	(b) If the design-build contractor makes design-build team
24	changes in violation of Subsection (a), any cost savings resulting

- 2 design-build contractor.
- 3 SECTION 2. Subchapter K, Chapter 370, Transportation Code,
- 4 is amended by adding Section 370.4075 to read as follows:
- 5 Sec. 370.4075. CHANGES TO DESIGN-BUILD TEAM. (a)
- 6 design-build contractor selected for a contract may not make
- 7 changes to companies or entities identified as part of the
- 8 design-build team in a response to a request for proposals unless an
- 9 identified company or entity:
- 10 (1) is no longer in business, is unable to fulfill its
- 11 legal, financial, or business obligations, or can no longer meet
- 12 the terms of the teaming agreement proposed for the project with the
- 13 design-build contractor;
- 14 (2) voluntarily removes itself from the team;
- 15 (3) fails to provide a sufficient number of qualified

- 18 (4) fails to negotiate in good faith in a timely manner
- 19 <u>in accordance with provisions established in the teaming agreement</u>
- 20 proposed for the project.
- 21 (b) If the design-build contractor makes design-build team

- 23 from the changes accrue to the authority and not to the design-build
- 24 contractor.
- 25 SECTION 3. The changes in law made by this Act apply only to
- 26 a contract, highway project, or transportation project for which
- 27 the Texas Department of Transportation or an authority under

- 1 Chapter 370, Transportation Code, first advertises or otherwise
- 2 requests proposals or qualifications on or after the effective date
- 3 of this Act.
- 4 SECTION 4. This Act takes effect September 1, 2019.
