4 SECTION 4. Sections 9601.051(f) and (g), Special District 5 Local Laws Code, are repealed.

6 SECTION 5. (a) The legal notice of the intention to 7 introduce this Act, setting forth the general substance of this 8 Act, has been published as provided by law, and the notice and a 9 copy of this Act have been furnished to all persons, agencies, 10 officials, or entities to which they are required to be furnished 11 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 12 Government Code.

13 (b) The governor, one of the required recipients, has 14 submitted the notice and Act to the Texas Commission on 15 Environmental Quality.

16 (c) The Texas Commission on Environmental Quality has filed 17 its recommendations relating to this Act with the governor, the 18 lieutenant governor, and the speaker of the house of 19 representatives within the required time.

20 (d) All requirements of the constitution and laws of this 21 state and the rules and procedures of the legislature with respect 22 to the notice, introduction, and passage of this Act are fulfilled 23 and accomplished.

SECTION 6. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
