5	SECTION 1. Subchapter A, Chapter 33, Education Code, is
6	amended by adding Section 33.010 to read as follows:
7	Sec. 33.010. LIFE SKILLS COUNSELOR PILOT PROGRAM. (a) In
8	this section:
9	(1) "Crime of violence" has the meaning assigned by
10	Article 59.01, Code of Criminal Procedure.
11	(2) "Pilot program" means the life skills counselor
12	pilot program established under this section.
13	(b) This section applies only to a county that:
14	(1) is adjacent to:
15	(A) at least two counties that border the Gulf of
16	Mexico; and
17	(B) at least two counties that are located on the
18	international border; and
19	(2) is located within 50 miles of a county described by
20	Subdivision (1).
21	(c) The commissioner shall establish a life skills
22	counselor pilot program at each high school campus located in a
23	county subject to this section as a strategy for addressing
24	emotional and mental health concerns of students.

(d) A school district located in a county subject to this 1 section shall employ for each district high school campus located 2 in the county a school counselor certified under Subchapter B, 3 Chapter 21, to serve as a life skills counselor under the pilot 4 5 program. 6 (e) A life skills counselor employed to serve at a high 7 school campus under this section shall: 8 (1) collaborate with school district administrators, school counselors, social workers, other appropriately 9 credentialed mental health professionals, and local law 10 enforcement agencies to address mental health concerns affecting 11 12 students at the high school campus; (2) provide instruction to students enrolled at the 13 14 high school campus relating to skills and techniques to cope with 15 anxiety, frustration, and other emotions; 16 (3) counsel any students enrolled at the high school campus who have committed a crime of violence or are identified as 17 having a mental health condition; and 18 (4) establish a voluntary counseling program for 19 students enrolled at the high school campus. 20 21 (f) A school district located in a county subject to this section may solicit and accept a gift, grant, or donation from any 22 source, including a foundation, private entity, governmental 23 24 entity, or institution of higher education to implement or administer the pilot program. 25 26 (g) Not later than January 1, 2025, the commissioner shall review the pilot program established under this section and submit 27

to the governor, the lieutenant governor, the speaker of the house of representatives, and the presiding officer of each legislative standing committee with primary jurisdiction over primary and secondary education a written report regarding the progress made by the pilot program in addressing emotional and mental health concerns of students.

7 (h) The commissioner shall adopt rules necessary to 8 administer the pilot program.

(i) This section expires September 1, 2025.

10 SECTION 2. (a) Not later than December 1, 2019, the 11 commissioner of education shall adopt rules necessary to implement 12 and administer the life skills counselor pilot program established 13 under Section 33.010, Education Code, as added by this Act.

(b) The life skills counselor pilot program established under Section 33.010, Education Code, as added by this Act, shall be implemented in each public high school located in a county subject to that section beginning with the 2020-2021 school year.

18 SECTION 3. This Act takes effect immediately if it receives 19 a vote of two-thirds of all the members elected to each house, as 20 provided by Section 39, Article III, Texas Constitution. If this 21 Act does not receive the vote necessary for immediate effect, this 22 Act takes effect September 1, 2019.
