FINDINGS OF PUBLIC PURPOSE AND BENEFIT. 11 12 (a) The district is created to serve a public purpose and benefit. (b) The district is created to accomplish the purposes of: 13 14 (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and 15 (2) Section 52, Article III, Texas Constitution, that 16 relate to the construction, acquisition, improvement, operation, 17 or maintenance of macadamized, graveled, or paved roads, or 18 improvements, including storm drainage, in aid of those roads. 19 SUBCHAPTER B. POWERS AND DUTIES 20 21 Sec. 8034.0201. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, 22 23 acquire, construct, finance, issue bonds for, improve, operate, maintain, and convey to this state, a county, or a municipality for 24

1 operation and maintenance macadamized, graveled, or paved roads, or 2 improvements, including storm drainage, in aid of those roads. Sec. 8034.0202. ROAD STANDARDS AND REQUIREMENTS. (a) A 3 road project must meet all applicable construction standards, 4 zoning and subdivision requirements, and regulations of each 5 municipality in whose corporate limits or extraterritorial 6 jurisdiction the road project is located. 7 8 (b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road 9 project must meet all applicable construction standards, 10 subdivision requirements, and regulations of each county in which 11 12 the road project is located. (c) If the state will maintain and operate the road, the 13 Texas Transportation Commission must approve the plans and 14 specifications of the road project. 15 SUBCHAPTER C. BONDS 16 17 Sec. 8034.0301. BONDS FOR ROAD PROJECTS. At the time of issuance, the total principal amount of bonds or other obligations 18 19 issued or incurred to finance road projects and payable from ad

20 valorem taxes may not exceed one-fourth of the assessed value of the 21 real property in the district.

22 SECTION 2. (a) The legal notice of the intention to 23 introduce this Act, setting forth the general substance of this 24 Act, has been published as provided by law, and the notice and a 25 copy of this Act have been furnished to all persons, agencies, 26 officials, or entities to which they are required to be furnished 27 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

2 (b) The governor, one of the required recipients, has 3 submitted the notice and Act to the Texas Commission on 4 Environmental Quality.

The Texas Commission on Environmental Quality has filed 5 (c) 6 its recommendations relating to this Act with the governor, the 7 lieutenant governor, and the speaker of the house of 8 representatives within the required time.

9 (d) All requirements of the constitution and laws of this 10 state and the rules and procedures of the legislature with respect 11 to the notice, introduction, and passage of this Act are fulfilled 12 and accomplished.

13 SECTION 3. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2019.
