SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8035 to read as follows: CHAPTER 8035. HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 380 SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8035.0102. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. The district is created to serve a public purpose and benefit. (b) The district is created to accomplish the purposes of: <u>(</u>a)

(1) a municipal utility district as provided 1-29 by general law and Section 59, Article XVI, Texas Constitution; and (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, or maintenance of macadamized, graveled, or paved roads, or 1-30 1-31

Sec. 8035.0201. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, acquire, construct, finance, issue bonds for, improve, operate, 1-36 1-37 1-38 maintain, and convey to this state, a county, or a municipality for 1-39 operation and maintenance macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads. Sec. 8035.0202. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, 1-40 1-41
