3 "An advance of money obtained through a payday loan or auto 4 title loan is not intended to meet long-term financial needs. A 5 payday loan or auto title loan should only be used to meet immediate 6 short-term cash needs. 9 SECTION 3. Section 393.223(a), Finance Code, is amended to 10 read as follows:

(a) Before performing services described by Section 393.221(1), a credit access business must provide to a consumer a disclosure adopted by rule of the Finance Commission of Texas that discloses the following in a form prescribed by the commission:

(1) the interest, fees, and annual percentage rates, as applicable, to be charged on <u>the extension of consumer credit</u> <u>that the credit access business proposes to obtain for the consumer</u> <u>or assist the consumer in obtaining</u> [<u>a deferred presentment</u> <u>transaction or on a motor vehicle title loan, as applicable,</u>] in comparison to interest, fees, and annual percentage rates to be charged on other alternative forms of consumer debt;

(2) the amount of accumulated fees a consumer would
incur by renewing or refinancing <u>the extension of consumer credit</u>
<u>if it were to remain</u> [a deferred presentment transaction or motor
vehicle title loan that remains] outstanding for a period of two
weeks, one month, two months, and three months; and

3 SECTION 4. Section 393.601(2), Finance Code, is amended to 4 read as follows:

5 (2) "Credit access business" means a credit services 6 organization that obtains for a consumer or assists a consumer in 7 obtaining an extension of consumer credit, including an extension 8 <u>of consumer credit</u> in the form of a deferred presentment 9 transaction or a motor vehicle title loan.

SECTION 5. Section 393.602(a), Finance Code, is amended to read as follows:

(a) This subchapter applies only to a credit services
organization that obtains for a consumer or assists a consumer in
obtaining an extension of consumer credit [in the form of:

[(1) a deferred presentment transaction; or

[(2) a motor vehicle title loan].

SECTION 6. The changes in law made by this Act apply only to an extension of consumer credit made on or after the effective date of this Act. An extension of consumer credit made before the effective date of this Act is governed by the law in effect on the date the extension of consumer credit was made, and the former law is continued in effect for that purpose.
