A BILL TO BE ENTITLED 1 AN ACT 2 relating to requiring a voter to present proof of identification. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 13.002(i), Election Code, is amended to 5 read as follows: 6 (i) An applicant who wishes to receive an exemption from the 7 requirements of Section 63.001(b) on the basis of disability must include with the person's application: 8 (1) written documentation: 9 (A) from the United States Social Security 10 11 Administration evidencing the applicant has been determined to have 12 a disability; or 13 (B) from the United States Department of Veterans 14 Affairs evidencing the applicant has a disability rating of at least 50 percent; and 15 a statement in a form prescribed by the secretary 16 (2) of state that the applicant does not have [a form of] identification 17 required by Section 63.001(b) in a form described by [acceptable 18 under] Section 63.0101. 19 SECTION 2. Sections 63.001(b) and (i), Election Code, are 20 21 amended to read as follows: 22 (b) Except as provided by Subsection (h), on offering to 23 vote, a voter must present to an election officer at the polling place: 24

(1) one form of photo identification listed in Section

If the requirement for identification prescribed by 12 (i) Subsection (b)(1) or (3) is not met, an election officer shall 13 14 notify the voter that the voter may be accepted for voting if the 15 voter meets the requirement for identification prescribed by Subsection (b)(2) or (4) and executes a declaration declaring the 16 17 voter has a reasonable impediment to meeting the requirement for identification prescribed by Subsection (b)(1) or (3). A person is 18 19 subject to prosecution for perjury under Chapter 37, Penal Code, or Section 63.0013 for a false statement or false information on the 20 declaration. The secretary of state shall prescribe the form of the 21 22 declaration. The form shall include:

No. 1799 1 person described in the declaration is the same person appearing at the polling place to sign the declaration, and that the voter faces 2 3 a reasonable impediment to procuring the identification prescribed by Subsection (b)(1) or (3); 4 5 (3) a place for the voter to indicate one of the following impediments: 6 7 lack of transportation; (A) lack of birth certificate or other documents 8 (B) needed to obtain the identification prescribed by Subsection 9 10 (b)(1); (C) work schedule; 11 12 (D) lost or stolen identification; disability or illness; 13 (E) 14 (F) family responsibilities; and 15 (G) the identification prescribed by Subsection (b)(1) or (3) has been applied for but not received; 16 17 (4) a place for the voter to sign and date the declaration; 18 19 (5)a place for the election judge to sign and date the declaration; 20 21 a place to note the polling place at which the (6) declaration is signed; and 22 23 (7) a place for the election judge to note which form 24 of identification prescribed by Subsection (b)(2) or (4) the voter 25 presented. 26 SECTION 3. Sections 63.0101(a) and (b), Election Code, are 27 amended to read as follows:

(a) The following documentation is an acceptable form of photo identification under this chapter: 2

3 (1) a driver's license, election identification certificate, or personal identification card issued to the voter 4 5 [person] by the Department of Public Safety that has not expired or that expired no earlier than four years before the date of 6 presentation; 7

8 (2)a United States military identification card that contains the voter's [person's] photograph that has not expired or 9 10 that expired no earlier than four years before the date of presentation; 11

a United States citizenship certificate issued to 12 (3) the voter [person] that contains the voter's [person's] photograph; 13

14 (4) a United States passport book or card issued to the 15 voter [person] that has not expired or that expired no earlier than four years before the date of presentation; [or] 16

17 (5) a license to carry a handgun issued to the voter [person] by the Department of Public Safety that has not expired or 18 that expired no earlier than four years before the date of 19 20 presentation;

(6) an official Native American tribal document that:

(A) contains the voter's photograph and address;

26 (7) any other official government document issued to the voter and containing the voter's name, address, and photograph. 27

Section 63.011(b), Election Code, is amended to 9 read as follows: A form for an affidavit required by this section must be 10 (b) printed on an envelope in which the provisional ballot voted by the 11 12 person may be placed and must include: a space for entering the identification number of 13 (1)14 the provisional ballot voted by the person; and 15 (2) a space for an election officer to indicate 16 whether the person presented [a form of] identification required by 17 Section 63.001(b) in a form described by Section 63.0101. SECTION 5. Section 65.0541(a), Election Code, is amended to 18 read as follows: 19 20 (a) A voter who is accepted for provisional voting under Section 63.011 because the voter does not meet the identification 21 requirements of Section 63.001(b) may, not later than the sixth day 22 after the date of the election: 23 24 (1) present [a form of] identification required by Section 63.001(b) in a form described by Section 63.0101 to the 25 26 voter registrar for examination; or 27 (2) execute an affidavit described by Section

1 65.054(b)(2)(B) or (C) in the presence of the voter registrar.

2 SECTION 6. Section 86.006(a-1), Election Code, is amended 3 to read as follows:

4 (a-1) The voter may deliver a marked ballot in person to the
5 early voting clerk's office only while the polls are open on
6 election day. A voter who delivers a marked ballot in person must
7 present <u>identification required by Section 63.001(b) in a</u> [an
8 acceptable] form [of identification] described by Section 63.0101.
9 SECTION 7. This Act takes effect September 1, 2019.
