4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle D, Title 2, Health and Safety Code, is
6	amended by adding Chapter 99 to read as follows:
7	CHAPTER 99. STATE PLAN FOR ALZHEIMER'S DISEASE AND RELATED
8	DISORDERS
9	Sec. 99.001. DEVELOPMENT AND IMPLEMENTATION OF STATE PLAN.
10	(a) The department, using existing resources and programs to the
11	extent possible, shall develop and implement a state plan for
12	education on and treatment of Alzheimer's disease and related
13	disorders.
14	(b) The state plan must include best practices and
15	strategies for:
16	(1) improving early detection of, reducing disease
17	onset risks for, and improving treatment of Alzheimer's disease and
18	related disorders for specific demographic groups;
19	(2) educating health care professionals, caregivers,
20	and the public to increase awareness of Alzheimer's disease and
21	related disorders;
22	(3) providing caregiver support;
23	(4) advancing basic science and applied research
24	related to Alzheimer's disease and related disorders; and

- 1 (5) collecting and evaluating information on efforts
- 2 to prevent and treat Alzheimer's disease and related disorders.
- 3 Sec. 99.002. COMMENTS FROM INTERESTED PARTIES. (a) In
- 4 developing the state plan under Section 99.001, the department
- 5 shall seek comments from interested parties, including:
- 6 (1) members of the public with, or who care for persons
- 7 with, Alzheimer's disease or related disorders;
- 8 (2) each state agency that provides services to
- 9 persons with Alzheimer's disease or related disorders;
- 10 (3) any advisory body that addresses issues related to
- 11 Alzheimer's disease or related disorders;
- 12 (4) public advocates concerned with issues related to
- 13 Alzheimer's disease or related disorders;
- 14 (5) health care providers who provide services to
- 15 persons with Alzheimer's disease or related disorders; and
- 16 (6) researchers of issues affecting persons with
- 17 Alzheimer's disease or related disorders.
- 18 (b) On request of the department, the commission shall
- 19 provide information and comments related to services provided to
- 20 persons with Alzheimer's disease or related disorders.
- 21 <u>(c)</u> The department shall meet with interested parties at
- 22 least two times each year to:
- (1) facilitate comments on and discuss the progress of
- 24 developing and implementing the state plan developed under this
- 25 chapter; and
- 26 (2) gather information for the report required under
- 27 Section 99.004.

- 1 Sec. 99.003. REVIEW AND MODIFICATION OF STATE PLAN. The
- 2 department shall conduct a review and modify as necessary the state
- 3 plan developed under this chapter at least once every five years.
- 4 Sec. 99.004. REPORT. Not later than September 1 of each
- 5 even-numbered year, the department shall submit to the legislature
- 6 <u>a report on the development and implementation or the review or</u>
- 7 modification of the state plan developed under this chapter.
- 8 Sec. 99.005. GIFTS AND GRANTS. The department may accept
- 9 gifts and grants from any source to fund the duties of the
- 10 department under this chapter.
- 11 SECTION 2. This Act takes effect September 1, 2019.
