Section 493.010, Government Code, is amended to read as follows: 7 Sec. 493.010. CONTRACTS FOR MISCELLANEOUS HOUSING. (a) The 8 9 board, for the temporary or permanent housing of inmates, may enter into leases or contract with: 10 11 (1) public or private jails; or 12 (2) operators of alternative housing facilities. 13 (b) The board may not enter into a lease or contract with an operator of an alternative housing facility that is located in a 14 county with a population of 3.3 million or more unless the operator 15 16 submits to the board a permit or other documentation showing that the facility is in compliance with all applicable municipal and 17 county regulations. 18 SECTION 2. Chapter 508, Government Code, is amended by 19 adding Subchapter E-1 to read as follows: 20 21 SUBCHAPTER E-1. ALTERNATIVE HOUSING IN CERTAIN COUNTIES 22 Sec. 508.171. APPLICABILITY. This subchapter applies only 23 with respect to alternative housing that is located in a county with a population of 3.3 million or more. 24

The department 1 2 shall require that an applicant to participate as a provider in a program designed to provide alternative housing for two or more 3 unrelated releasees submit with the application, in the manner 4 5 specified by the department, a permit or other documentation showing that the proposed alternative housing facility is in 6 7 compliance with all applicable municipal and county regulations. Sec. 508.173. INFORMATION REGARDING ALTERNATIVE HOUSING; 8 NOTICE TO POLITICAL SUBDIVISION. (a) The department shall 9 maintain the following information regarding releasees: 10 (1) a <u>list of facilities providing alternative housing</u> 11 12 to two or more unrelated releasees, including: (A) the name, address, and telephone number of 13 14 the facility; 15 (B) the county in which the facility is located; 16 (C) information regarding whether the facility is in compliance with all applicable municipal and county 17 18 regulations; 19 (D) the number of releasees residing at the 20 facility; and 21 (E) the maximum capacity of the facility; and 22 (2) a list of releasees being housed at a facility described by Subdivision (1), including: 23 24 (A) the releasee's name; (B) the county in which the release is required 25 26 to reside under Section 508.181; 27 (C) the county in which the releasee committed

No. 1956 1 the offense for which the releasee is on parole or mandatory 2 supervision; 3 (D) the alternative housing facility in which the releasee resides; and 4 5 (E) the date on which the releasee began residing 6 at the facility. 7 (b) On request of a county or municipality, the department 8 shall provide monthly the information maintained by the department under Subsection (a). A county or municipality shall notify the 9 10 department if the county or municipality does not want to continue to receive the information. 11 12 (c) The department shall provide the information to a county or municipality under Subsection (b) by secured electronic mail and 13 in a machine-readable format. 14 15 (d) On request by a member of the legislature, the department shall provide the information maintained by the 16 17 department under Subsection (a) to the member. Section 493.010, Government Code, SECTION 3. (a) 18 as 19 amended by this Act, applies only to a lease or contract entered into on or after the effective date of this Act. 20 21 (b) Section 508.172, Government Code, as added by this Act, applies only to an application to participate in a program 22 described by that section that is submitted on or after the 23 24 effective date of this Act. SECTION 4. This Act takes effect September 1, 2019. 25
