- 5 SECTION 1. Section 105.01(a), Alcoholic Beverage Code, is
- 6 amended to read as follows:
- 7 (a) Except as provided in Sections 105.02, 105.03, 105.04,
- 8 [and] 105.08, and 105.091, no person may sell, offer for sale, or
- 9 deliver any liquor:
- 10 (1) on New Year's Day, Thanksgiving Day, or Christmas
- 11 Day;
- 12 (2) on Sunday; or
- 13 (3) before 10 a.m. or after 9 p.m. on any other day.
- 14 SECTION 2. Section 105.06, Alcoholic Beverage Code, is
- 15 amended by amending Subsections (b) and (c) and adding Subsection
- 16 (f) to read as follows:
- 17 (b) Except as provided by Subsection (f), in [In] a standard
- 18 hours area, a person commits an offense if the person [he] consumes
- 19 or possesses with intent to consume an alcoholic beverage in a
- 20 public place at any time on Sunday between 1:15 a.m. and 12 noon or
- 21 on any other day between 12:15 a.m. and 7 a.m.
- (c) Except as provided by Subsection (f), in $[\frac{1}{2}]$ an
- 23 extended hours area, a person commits an offense if the person [he]
- 24 consumes or possesses with intent to consume an alcoholic beverage

- 2 and on any other day between 2:15 a.m. and 7 a.m.
- 3 (f) A person who is a registered guest of a hotel may consume
- 4 or possess alcoholic beverages in the hotel bar, as defined by
- 5 Section 105.091, at any time.
- 6 SECTION 3. Chapter 105, Alcoholic Beverage Code, is amended
- 7 by adding Section 105.091 to read as follows:
- 8 Sec. 105.091. HOURS OF SALE; HOTEL BAR. (a) In this
- 9 section, "hotel bar" means an establishment that is located in a
- 10 hotel and holds a permit or license providing for the on-premises
- 11 consumption of alcoholic beverages.
- 12 <u>(b) Notwithstanding any other law, a hotel bar may sell or</u>
- 13 offer for sale alcoholic beverages at any time to a registered guest
- 14 of the hotel.
- 15 SECTION 4. This Act takes effect September 1, 2019.
