1-17 relating to required notice for municipal management districts that
1-18 annex or exclude territory.

1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 375.043, Local Government Code, is
1-21 amended to read as follows:

1-22 Sec. 375.043. ANNEXATION; NOTICE OF BOUNDARIES. (a) A
1-23 district may annex land as provided by Section 49.301 and Chapter
1-24 54, Water Code, subject to the approval of the governing body of the
1-25 municipality.

1-26 (b) Not later than the 90th day after the date a district
1-27 annexes land under Subsection (a), the district shall provide a
1-28 description of the metes and bounds of the district, as of the date
1-29 the annexation takes effect, to each municipality that, on the date
1-30 the annexation takes effect:

1-31 (1) has territory that overlaps with the district's
1-32 territory; or

1-33 (2) is adjacent to the district.

1-34 (c) The district is not required to provide the description
1-35 of the metes and bounds required under Subsection (b) to a
1-36 municipality that has waived in writing the municipality's right to
1-37 the description.

1-38 SECTION 2. The heading to Section 375.044, Local Government
1-39 Code, is amended to read as follows:

1-40 Sec. 375.044. EXCLUDING TERRITORY; NOTICE OF BOUNDARIES.

1-41 SECTION 3. Section 375.044, Local Government Code, is
1-42 amended by adding Subsections (c) and (d) to read as follows:

1-43 (c) Not later than the 90th day after the date a district
1-44 excludes land under this section, the district shall provide a
1-45 description of the metes and bounds of the district, as of the date
1-46 the exclusion takes effect, to each municipality that, on the date
1-47 the exclusion takes effect:

1-48 (1) has territory that overlaps with the district's
1-49 territory; or

1-50 (2) is adjacent to the district.

1-51 (d) The district is not required to provide the description
1-52 of the metes and bounds required under Subsection (c) to a
1-53 municipality that has waived in writing the municipality's right to
1-54 the description.

1-55 SECTION 4. This Act takes effect September 1, 2019.
