21	(3) the issuance of election identification

2	(b) The committee shall review plans and receive updates
3	from state and local governmental entities involved with the
4	administration and implementation of the department's duties

6	Sec. 526.003. COMPOSITION. (a) The committee is composed
7	of eight members as follows:
8	(1) four members of the senate appointed by the
9	lieutenant governor; and
10	(2) four members of the house of representatives
11	appointed by the speaker of the house of representatives.
12	(b) The chair of the committee shall alternate biennially
13	between:
14	(1) a member of the senate appointed by the lieutenant

5 SECTION 3. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2019.
