4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle B, Title 7, Election Code, is amended by
6	adding Chapter 107 to read as follows:
7	CHAPTER 107. EARLY VOTING BY PERSON IN SPECIAL CIRCUMSTANCE
8	Sec. 107.001. APPLICABILITY. This chapter applies only to
9	<u>a voter:</u>
10	(1) who is eligible to vote in this state; and
11	(2) whose occupation causes a hardship for the voter
12	to appear at the polling place on election day because the voter is
13	<pre>employed:</pre>
14	(A) in an occupation that causes the voter to be
15	working periodically offshore;
16	(B) as a truck driver whose routes routinely take
17	the voter more than 200 miles from the voter's residence;
18	(C) in an occupation that may require the voter
19	to be overseas on election day but for which voting under Chapter
20	101 is not applicable; or
21	(D) as the permanent caretaker of a person who
22	has a disability and the voter's presence is necessary to protect
23	the life or safety of the person who has a disability and will

1 2 (Signature of physician, chiropractor, or practitioner)" (b) The application must be submitted to the early voting 3 clerk not later than the 60th day before election day for the 4 5 applicant to be eligible to vote a ballot under this chapter. 6 Sec. 107.003. VOTING PROCEDURE; PROCESSING RESULTS. 7 On submission of an application under this chapter to the early 8 voting clerk, the clerk shall review the application and verify the applicant's registration status in accordance with the procedure 9 10 applicable to early voting by mail. (b) The voting shall be conducted with the balloting 11 12 materials for early voting by mail. (c) The address to which the balloting materials must be 13 14 addressed is the address at which the voter is registered to vote or 15 the address of the applicant's employer or of a person related to the applicant within the second degree by affinity or the third 16 17 degree by consanguinity, as determined under Chapter 573, Government Code. 18 19 The voter must mark and seal the ballot in the same manner as if early voting by mail. 20 21 (e) The results shall be processed in accordance with the procedures applicable to processing early voting ballots voted by 22 23 mail. 24 (f) Section 86.0015 applies to an application for a ballot
