1-19 relating to required human trafficking prevention training as a condition of registration permit or license renewal for certain 1-20 health care practitioners. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-21 1-22 1**-**23 SECTION 1. Subtitle A, Title 3, Occupations Code, is amended by adding Chapter 116 to read as follows: 1-24

CHAPTER 116. TRAINING COURSE ON HUMAN TRAFFICKING PREVENTION 1-25 1-26

Sec. 116.001. DEFINITIONS. In this chapter: (1) "Commission" means the Health and Human Services 1-27 1-28 Commission.

1-29 (2) "Executive commissioner" the means executive 1-30 commissioner of the Health and Human Services Commission.

"Health care practitioner" means an individual who 1-31 (3) ' holds a license, certificate, permit, or other authorization issued under this title to engage in a health care profession and who 1-32 1-33 1-34 provides direct patient care.

1-35 Sec. 116.002. REQUIRED TRAINING COURSE ON HUMAN TRAFFICKING PREVENTION FOR CERTAIN HEALTH CARE PROVIDERS. (a) A health care practitioner, other than a physician or nurse, within the time prescribed by commission rule shall successfully complete a training course approved by the executive commissioner on 1-36 1-37 1-38 1-39 identifying and assisting victims of human trafficking. 1-40 1-41

(b) The executive commissioner shall:

(1) approve training courses on human trafficking including at least one course that is available without 1-42 1-43 prevention, charge; and 1-44

(a) As soon as practicable after the effective date of this Act, the applicable licensing agency shall provide 2**-**25 2**-**26 2-27 notice to a health care practitioner of the human trafficking prevention training required under Chapter 116, Occupations Code, 2-28 2-29 as added by this Act.

2-30 (b) Notwithstanding Section 116.002, Occupations Code, as 2-31 added by this Act, a health care practitioner is not required to 2-32 comply with that section before September 1, 2020.

SECTION 6. Sections 156.060 and 301.308, Occupations Code, as added by this Act, apply only to the renewal of a registration permit to practice medicine or the renewal of a license to practice nursing on or after September 1, 2020. The renewal of a registration permit or license before that date is governed by the 2-33 2-34 2-35 2-36 2-37 2-38 law in effect immediately before the effective date of this Act, and the former law is continued in effect for that purpose. SECTION 7. This Act takes effect September 1, 2019. 2-39
