- 2 relating to license terms and fees and registration and listing
- 3 fees for certain child-care facilities.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 42.048(f), Human Resources Code, is
- 6 amended to read as follows:
- 7 (f) A license must be issued if the <u>commission</u> [department]
- 8 determines that a facility meets all requirements. The evaluation
- 9 shall be based on one or more visits to the facility and a review of
- 10 required forms and records. A license is valid until [the license
- 11 expires, is revoked[$_{\tau}$] or [is] surrendered.
- 12 SECTION 2. Sections 42.054(a), (b), (c), (d), and (e),
- 13 Human Resources Code, are amended to read as follows:
- 14 (a) The commission [department] shall charge an applicant a
- 15 nonrefundable application fee in the amount of \$35 for an initial
- 16 license to operate a child-care facility, a child-placing agency,
- 17 or a continuum-of-care residential operation.
- 18 (b) The <u>commission</u> [<u>department</u>] shall charge each
- 19 child-care facility a fee in the amount of \$35 for an initial
- 20 license. The <u>commission</u> [department] shall charge each
- 21 child-placing agency and continuum-of-care residential operation a
- 22 fee in the amount of \$50 for an initial license.
- (c) The commission [department] shall charge each licensed
- 24 child-care facility an annual license fee in an amount equal to \$35

- 1 plus \$1 multiplied by the maximum number of children for whom the
- 2 child-care facility is authorized to provide care. The fee is due
- 3 on the date on which the commission [department] issues the
- 4 child-care facility's initial license and on the anniversary of
- 5 that date.
- 6 (d) The <u>commission</u> [<u>department</u>] shall charge each licensed
- 7 child-placing agency and continuum-of-care residential operation
- 8 an annual license fee in the amount of \$100. The fee is due on the
- 9 date on which the commission [department] issues the initial
- 10 license to the child-placing agency or continuum-of-care
- 11 residential operation and on the anniversary of that date.
- (e) The commission [department] shall charge each family
- 13 home that is listed or registered with the commission [department]
- 14 an annual fee to cover a part of the commission's cost in regulating
- 15 <u>family homes.</u> The amount of the fee is \$20 for a listed home or \$35
- 16 for a registered home. The fee is due on the date on which the
- 17 <u>commission</u> [department] initially lists or registers the home and
- 18 on the anniversary of that date.
- 19 SECTION 3. Sections 42.050 and 42.054(h), Human Resources
- 20 Code, are repealed.
- 21 SECTION 4. The changes in law made by this Act apply only to
- 22 an application fee paid or license fee or registration and listing
- 23 fee due on or after the effective date of this Act. An application
- 24 fee paid or license fee or registration and listing fee due before
- 25 that date is governed by the law in effect on the date the fee was
- 26 paid or due, as applicable, and that law is continued in effect for
- 27 that purpose.

1 SECTION 5. This Act takes effect September 1, 2019.
