- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 57.051, Water Code, is amended to read as
- 6 follows:
- 7 Sec. 57.051. APPOINTMENT OF BOARD OF DIRECTORS. (a) The
- 8 commissioners court which creates a levee improvement district
- 9 under this chapter, by majority vote, shall appoint three directors
- 10 for the district.
- 11 (b) In a district with a population of 2,000 or more the
- 12 commissioners court may increase the total number of directors to
- 13 five. The additional members appointed under this section must be
- 14 registered voters in the district.
- 15 SECTION 2. Section 57.058, Water Code, is amended to read as
- 16 follows:
- 17 Sec. 57.058. NUMBER OF ELECTED DIRECTORS; TERMS. In
- 18 districts which have elected boards, there shall be five directors
- 19 on the board. The initial elected directors shall draw lots to
- 20 determine which two initial directors serve two-year terms and
- 21 which three initial directors serve four-year terms. In countywide
- 22 districts, one director shall be elected by the electors of the
- 23 entire district and one director elected from each county
- 24 commissioners precinct by the electors of that precinct. In other

- 1 districts, all five directors shall be elected from precincts
- 2 within the district to be established by the commissioners court.
- 3 SECTION 3. Section 57.060, Water Code, is amended to read as
- 4 follows:
- 5 Sec. 57.060. PETITION. Before an election is held under
- 6 Section 57.057, a petition, signed by the greater of at least 10
- 7 percent of the total number of $[\frac{100}{100}]$ electors or 100 electors in the
- 8 district who are qualified to vote, shall be presented to the
- 9 district requesting that an election be held in the district to
- 10 determine whether or not directors for the district should be
- 11 elected [and, if so, to elect directors to serve until the next
- 12 regular director election. The petition shall include the name of
- 13 one or more nominees for each director's position]. If the results
- 14 of an election held under Section 57.057 determine that directors
- 15 will be elected, the current directors continue to serve until the
- 16 <u>elected directors qualify to take office.</u>
- 17 SECTION 4. The changes in law made by this Act to Section
- 18 57.058, Water Code, apply only to an election of directors held on
- 19 or after the effective date of this Act. An election of directors
- 20 held before the effective date of this Act is subject to the law in
- 21 effect on the date the election is held, and that law is continued
- 22 in effect for that purpose.
- 23 SECTION 5. This Act takes effect September 1, 2019.
