- 5 SECTION 1. Section 61.001, Labor Code, is amended by adding

- (B) a payroll card account established by the

- SECTION 3. Section 61.017, Labor Code, is amended by adding

- Subsections (d) and (e) to read as follows: 1 2
- (d) An employer may elect to pay wages to an employee
- through a payroll card account plan that is linked to a federally 3
- insured financial institution and uses electronic funds transfer to 4
- 5 deposit wages in the employee's payroll card account. An employer
- who elects to pay wages through a payroll card account shall: 6
- 7 (1) not later than the 60th day before the date of the
