5 SECTION 3. Section 47.008(c), Health and Safety Code, is 6 amended to read as follows:

The executive commissioner by rule shall 7 (c) develop 8 guidelines to protect the confidentiality of patients in accordance with Chapter 159, Occupations Code, and require the written consent 9 of a parent or guardian of a patient before any individually 10 identifying information is provided to the department or the 11 12 primary statewide resource center established under Section 30.051, Education Code, as set out in this chapter. The department 13 14 and center shall permit a parent or guardian at any time to withdraw 15 information provided to the department or center under this chapter. 16

17 SECTION 4. As soon as practicable after the effective date 18 of this Act, the executive commissioner of the Health and Human 19 Services Commission shall adopt rules as necessary to implement the 20 changes in law made by this Act.
