5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter E, Chapter 1551, Insurance Code, is
7	amended by adding Section 1551.2131 to read as follows:
8	Sec. 1551.2131. CERTAIN CARRIERS PROHIBITED FROM BIDDING.
9	(a) The commissioner shall provide notice to the board of trustees
10	if the commissioner finds that a carrier has terminated a contract
11	with a physician or provider for the provision of services solely
12	because the physician or provider informed an enrollee in a health
13	benefit plan offered or administered by the carrier of the full
14	range of physicians and providers, including out-of-network
15	providers, available to the enrollee after previously being
16	sanctioned or penalized by the department for engaging in the
17	conduct described by this subsection.
18	(b) If the board of trustees receives notice under
19	Subsection (a) regarding a carrier, the carrier is prohibited from
20	submitting a bid under Section 1551.212 or 1551.213 for two
21	competitive bidding cycles.
22	SECTION 2. Subchapter C, Chapter 1575, Insurance Code, is
23	amended by adding Section 1575.1061 to read as follows:

Sec. 1575.1061. CERTAIN HEALTH CARE PROVIDERS PROHIBITED

- 1 FROM BIDDING. (a) The commissioner shall provide notice to the
- 2 trustee if the commissioner finds that a health care provider has
- 3 terminated a contract with a physician or provider for the
- 4 provision of services solely because the physician or provider
- 5 informed an enrollee in a health benefit plan offered or
- 6 administered by the health care provider of the full range of
- 7 physicians and providers, including out-of-network providers,
- 8 available to the enrollee after previously being sanctioned or
- 9 penalized by the department for engaging in the conduct described
- 10 by this subsection.
- 11 (b) If the trustee receives notice under Subsection (a)
- 12 regarding a health care provider described by Section 1575.109, the
- 13 health care provider is prohibited from submitting a bid under
- 14 Section 1575.106 for two competitive bidding cycles.
- SECTION 3. Subchapter B, Chapter 1579, Insurance Code, is
- 16 amended by adding Section 1579.0541 to read as follows:
- Sec. 1579.0541. CERTAIN HEALTH CARE AND BENEFIT PROVIDERS
- 18 PROHIBITED FROM BIDDING. (a) The commissioner shall provide
- 19 notice to the trustee if the commissioner finds that a health care
- 20 or benefit provider has terminated a contract with a physician or
- 21 provider for the provision of services solely because the physician
- 22 or provider informed an enrollee in a health coverage plan offered
- 23 or administered by the health care or benefit provider of the full
- 24 range of physicians and providers, including out-of-network
- 25 providers, available to the enrollee after previously being
- 26 sanctioned or penalized by the department for engaging in the
- 27 conduct described by this subsection.
