A BILL TO BE ENTITLED 1 AN ACT 2 relating to the punishment for, and civil liability related to actions to prevent, the criminal offense of theft involving a 3 package delivered to a residential or commercial property; 4 5 increasing criminal penalties. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 7 SECTION 1. The heading to Section 124.001, Civil Practice and Remedies Code, is amended to read as follows: 8 9 Sec. 124.001. DETENTION TO INVESTIGATE OWNERSHIP OF 10 PROPERTY. SECTION 2. Chapter 124, Civil Practice and Remedies Code, 11 12 is amended by adding Section 124.002 to read as follows: Sec. 124.002. DETENTION TO PREVENT THEFT OF PACKAGE. (a) A 13 14 person who reasonably believes that another is stealing or attempting to steal a package under the circumstances described by 15 Sections 31.03(e)(4)(G)(i) and (ii), Penal Code, is privileged to 16 detain the other person in a reasonable manner, including by use of 17 reasonable force, for a reasonable period to allow for the arrival 18 19 of law enforcement authorities. 20 (b) A person who is privileged to detain another under Subsection (a) is not liable for damages arising from the detention 21 22 of that person. 23 SECTION 3. Article 59.01(2), Code of Criminal Procedure, is 24 amended to read as follows:

Section 31.03(h), Penal Code, is amended by 18 19 adding Subdivision (7) to read as follows: (7) "Package" means a box, container, bag, or other 20 sealed article holding a good or product. 21 SECTION 6. (a) Except as provided by Subsection (b) of 22 this section, the change in law made by this Act applies only to an 23 24 offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is governed 25 26 by the law in effect on the date the offense was committed, and the

former law is continued in effect for that purpose. For purposes of

this subsection, an offense was committed before the effective date 1 of this Act if any element of the offense occurred before that date. 2 (b) Section 124.002, Civil Practice and Remedies Code, as 3 4 added by this Act, does not apply to a cause of action that accrued before the effective date of this Act. A cause of action that 5 6 accrued before the effective date of this Act is governed by the law applicable to the cause of action immediately before the effective 7 date of this Act, and that law is continued in effect for that 8 9 purpose.

SECTION 7. This Act takes effect September 1, 2019.
