H.B. No. 2526

A BILL TO BE ENTITLED

1 AN ACT
2 relating to criteria for admission of certain students into public
3 schools.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 25.001(b), Education Code, is amended to
6 read as follows:

7 (b) The board of trustees of a school district or its
8 designee shall admit into the public schools of the district free of
9 tuition a person who is over five and younger than 21 years of age on
10 the first day of September of the school year in which admission is
11 sought, and may admit a person who is at least 21 years of age and
12 under 26 years of age for the purpose of completing the requirements
13 for a high school diploma, if:

14 (1) the person and either parent of the person reside
15 in the school district;

16 (2) the person does not reside in the school district
17 but a parent of the person resides in the school district and that
18 parent is a joint managing conservator or the sole managing
19 conservator or possessory conservator of the person;

20 (3) the person and the person's guardian or other
21 person having lawful control of the person under a court order
22 reside within the school district;

23 (4) the person has established a separate residence
24 under Subsection (d);

1 (5) the person is homeless, as defined by 42 U.S.C.
2 Section 11302, regardless of the residence of the person, of either
3 parent of the person, or of the person's guardian or other person
4 having lawful control of the person;

5 (6) the person is a foreign exchange student placed
6 with a host family that resides in the school district by a
7 nationally recognized foreign exchange program, unless the school
8 district has applied for and been granted a waiver by the
9 commissioner under Subsection (e);

10 (7) the person resides at a residential facility
11 located in the district;

12 (8) the person resides in the school district and is 18
13 years of age or older or the person's disabilities of minority have
14 been removed; ~~[or]~~

15 (9) the person does not reside in the school district
16 but the grandparent of the person:

17 (A) resides in the school district; and

18 (B) provides a substantial amount of
19 after-school care for the person as determined by the board; or

20 (10) the person and either parent of the person reside
21 in a residence homestead, as defined by Section 11.13(j), Tax Code,
22 that is located on a parcel of property any part of which is located
23 in the school district.

24 SECTION 2. This Act takes effect immediately if it receives
25 a vote of two-thirds of all the members elected to each house, as
26 provided by Section 39, Article III, Texas Constitution. If this
27 Act does not receive the vote necessary for immediate effect, this
