- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 824.601(b-1) and (f), Government Code,
- 6 are amended to read as follows:
- 7 (b-1) Subsection (b) does not apply to a retiree:
- 8 (1) under Section 824.202 whose effective date of
- 9 retirement is on or before August 31, 2018; or
- 10 (2) who commits a minor violation of a provision of
- 11 this subchapter, including a minor violation of an exception
- 12 provided by Section 824.602, unless the violation occurs frequently
- 13 [January 1, 2011].
- 14 (f) The system shall [may] adopt rules necessary for
- 15 administering this subchapter, including rules necessary to
- 16 <u>implement Subsection (b-1)(2)</u>.
- 17 SECTION 2. Subchapter F, Chapter 825, Government Code, is
- 18 amended by adding Section 825.521 to read as follows:
- 19 Sec. 825.521. DEADLINE TO APPEAL FINAL ADMINISTRATIVE
- 20 DECISION. In adopting rules governing the appeal of a final
- 21 administrative decision made by the retirement system, the board of
- 22 <u>trustees shall ensure that rules establishing deadlines for the</u>
- 23 filing of an appeal afford a member or retiree at least the same
- 24 amount of time to file an appeal as the retirement system had to

1 <u>issue the retirement system's decision.</u>

- 2 SECTION 3. (a) A person who resumed employment after
- 3 retirement and whose benefit payments were suspended under Section
- 4 824.601, Government Code, as that section existed before amendment
- 5 by this Act, is entitled to the resumption of monthly benefit
- 6 payments if the person meets the requirements of Section
- 7 824.601(b-1), Government Code, as amended by this Act.
- 8 (b) The Teacher Retirement System of Texas shall resume
- 9 making monthly benefit payments to a person described by Subsection
- 10 (a) of this section on the first payment date occurring on or after
- 11 the effective date of this Act.
- 12 (c) A person who is entitled to the resumption of monthly
- 13 benefit payments under this section is not entitled to recover
- 14 benefit payments not made during the period the person's benefit
- 15 was suspended under Section 824.601, Government Code, as that
- 16 section existed before amendment by this Act.
- 17 SECTION 4. (a) As soon as practicable after the effective
- 18 date of this Act, the board of trustees of the Teacher Retirement
- 19 System of Texas shall adopt rules necessary to implement Section
- 20 825.521, Government Code, as added by this Act.
- 21 (b) The change in law made by Section 825.521, Government
- 22 Code, as added by this Act, applies only to the appeal of an
- 23 administrative decision of the Teacher Retirement System of Texas
- 24 made on or after January 1, 2020. An appeal of a decision made
- 25 before January 1, 2020, is governed by the law as it existed
- 26 immediately before the effective date of this Act, and that law is
- 27 continued in effect for that purpose.
