- 5 SECTION 1. Section 802.305(i)(2), Government Code, is
- 6 amended to read as follows:
- 7 (2) "State-financed public retirement system" means
- 8 the Employees Retirement System of Texas, including the law
- 9 enforcement, [and] custodial, and peace officer supplemental
- 10 retirement fund, or the Teacher Retirement System of Texas.
- 11 SECTION 2. Section 811.001, Government Code, is amended by
- 12 amending Subdivisions (6) and (14) and adding Subdivision (12-b) to
- 13 read as follows:
- 14 (6) "Combined retirement annuity" means the amount
- 15 payable on retirement for service credited as a member of the
- 16 employee class of membership plus any supplemental amount payable
- 17 from the law enforcement, [and] custodial, and peace officer
- 18 supplemental retirement fund.
- 19 (12-b) "Peace officer" means a person:
- (A) identified under Section 825.515 as being
- 21 employed in a position as a peace officer; and
- 22 <u>(B) certified as being a peace officer under</u>
- 23 Section 815.505.
- 24 (14) "Retiree" means a person who, except as provided

- 2 service that was credited to the person in a class of membership.
- 3 SECTION 3. Section 812.003, Government Code, is amended by
- 4 amending Subsections (b) and (c) and adding Subsection (b-1) to
- 5 read as follows:
- 6 (b) An office or employment that is included in the coverage
- 7 of the Teacher Retirement System of Texas, other than in a position
- 8 identified as a peace officer position under Section 825.515 in
- 9 which an election is made under Section 812.0035 or 812.0036, the
- 10 Judicial Retirement System of Texas Plan One, or the Judicial
- 11 Retirement System of Texas Plan Two or, except as provided by
- 12 Section 9.01, Chapter 238 (S.B. 378), Acts of the 73rd Legislature,
- 13 Regular Session, 1993, is with a university system or institution
- 14 of higher education, as defined by Section 61.003, Education Code,
- 15 is not a position with a department, commission, board, agency, or

- 18 who is certified as being employed in a position as a peace officer
- 19 under Section 815.505.
- 20 (c) Membership in the employee class is mandatory for

- SECTION 4. Subchapter A, Chapter 812, Government Code, is
- 24 amended by adding Sections 812.0035 and 812.0036 to read as

- 26 Sec. 812.0035. OPTIONAL MEMBERSHIP FOR CERTAIN LAW
- 27 ENFORCEMENT OFFICERS. (a) In lieu of participating in the Teacher

- 1 Retirement System of Texas, a person who is employed in a position
- 2 identified as a peace officer position for a public school other
- 3 than an institution of higher education under Section 825.515 may
- 4 elect, not later than the 60th day after the first date of
- 5 employment, to participate, or return to participation, in the
- 6 retirement system.
- 7 (b) An election by a person described by Subsection (a) to
- 8 participate in the retirement system must be on a form prescribed by
- 9 the retirement system for that purpose.
- (c) Sections 812.205 and 812.206 do not apply to a person
- 11 who makes an election under this section.
- 12 Sec. 812.0036. CERTAIN PEACE OFFICERS EMPLOYED ON AUGUST
- 13 31, 2019. (a) This section applies to a person who, on August 31,
- 14 2019:
- 15 (1) is a member of the Teacher Retirement System of
- 16 Texas, who:
- 17 (A) is identified under Section 825.515 as being
- 18 employed in a position as a peace officer for a public school that
- 19 is not an institution of higher education; and
- 20 (B) elects, not later than November 1, 2019, to
- 21 begin membership as a peace officer participating in the Employees
- 22 Retirement System of Texas law enforcement, custodial, and peace
- 23 officer supplemental retirement fund beginning January 1, 2020; or
- 24 (2) is a member of the Teacher Retirement System of
- 25 Texas and is a retiree of the Employees Retirement System of Texas
- 26 or a member of that system who is absent from service and who:
- (A) was employed as a law enforcement or

- 1 custodial officer;
- 2 (B) is identified under Section 825.515 as being
- 3 employed in a position as a peace officer for a public school that
- 4 <u>is not an institution of higher education; and</u>
- 5 (C) elects, not later than November 1, 2019, to
- 6 return to membership as a peace officer participating in the
- 7 Employees Retirement System of Texas law enforcement, custodial,
- 8 and peace officer supplemental retirement fund beginning January 1,
- 9 2020.
- 10 (b) For the purposes of this chapter, service credit earned
- 11 by a person described by Subsection (a)(1) is considered service
- 12 credit earned in two retirement systems and is subject to Section
- 13 803.201. The membership on which combined service credit is based
- 14 is service credit accrued:
- 15 (1) before beginning participation in the Employees
- 16 Retirement System of Texas law enforcement, custodial, and peace
- 17 officer supplemental retirement fund; and
- 18 <u>(2) after beginning participation in the Employees</u>
- 19 Retirement System of Texas law enforcement, custodial, and peace
- 20 officer supplemental retirement fund.
- 21 (c) For purposes of this chapter, service credit earned by a
- 22 person who makes an election under Subsection (a)(2) is governed by
- 23 Sections 812.201(d) and 812.2035. Service credit earned by that
- 24 person in the Teacher Retirement System of Texas before the
- 25 effective date of the election is transferred to the Employees
- 26 Retirement System of Texas as provided by Chapter 805 without
- 27 regard to the amount of service credit held in either system.

- 7 SECTION 6. Section 812.201, Government Code, is amended by
- 8 amending Subsection (a) and adding Subsection (d) to read as

- 10 (a) Except as provided by Subsection (c) or (d), a retiree
- 11 may not rejoin the retirement system as a member of the class from
- 12 which the person retired.
- (d) A person who is retired from the employee class of
- 14 membership and who is employed in a position identified as a peace
- 15 officer position for a public school other than an institution of
- 16 higher education under Section 825.515 may elect to become a member
- 17 again under Section 812.0035 by filing notice with the retirement
- 18 system. Except as provided by Section 812.2035(c), when benefit
- 19 payments are resumed, the retirement system shall recompute the
- 20 annuity selected at the time of the officer's original retirement
- 21 to include the additional service established during membership
- 22 under this subsection.
- 23 SECTION 7. Section 812.202(b), Government Code, is amended
- 24 to read as follows:
- 25 (b) Except as provided by Section 812.2035, the [The]
- 26 payment of benefits to a retiree for service credited in the
- 27 employee class of membership is not affected by the retiree's

- 1 taking a position included in the employee class.
- 2 SECTION 8. The heading to Section 812.203, Government Code,
- 3 is amended to read as follows:
- 4 Sec. 812.203. ELECTED CLASS BENEFITS AFFECTED.
- 5 SECTION 9. Subchapter C, Chapter 812, Government Code, is
- 6 amended by adding Section 812.2035 to read as follows:
- 7 Sec. 812.2035. CERTAIN EMPLOYEE CLASS BENEFITS AFFECTED.
- 8 (a) If a retiree takes a position as a peace officer and elects to
- 9 participate again in the system under Section 812.0035, the
- 10 retirement system shall suspend annuity payments to the person for
- 11 service that was credited in that class until the person no longer
- 12 holds that position.
- 13 (b) Time during which annuity payments are suspended as
- 14 provided by this section does not reduce the number of months
- 15 payments are to be made under an optional benefit selection
- 16 providing for a specific amount of benefits for a guaranteed number
- 17 of months after retirement.
- 18 (c) If a member who originally retired with service that
- 19 was, at the time of that retirement, credited only in the employee
- 20 class of membership again retires, the person at the time of
- 21 subsequent retirement may select an annuity based on service in the
- 22 employee class as if the person were retiring for the first time.
- 23 If the person selects an annuity under Section 814.108(c)(3) or
- 24 (c)(4), the retirement system shall reduce the number of months of

- 26 paid under the person's original retirement.

- 6 SECTION 11. Section 814.107, Government Code, is amended to

- 8 Sec. 814.107. SERVICE RETIREMENT BENEFITS FOR CERTAIN
- 9 [PEACE] OFFICERS. (a) This section applies only to a member who
- 10 participates in the law enforcement, custodial, and peace officer
- 11 <u>supplemental retirement fund.</u>
- 12 (a-1) A member who has at least 20 years of service credit as
- 13 a law enforcement, $[\frac{1}{2}]$ custodial, or peace officer is eligible to
- 14 retire regardless of age and receive a standard service retirement
- 15 annuity in an amount and to be funded as provided by this section.
- 16 (b) The standard service retirement annuity payable for at
- 17 least 20 years of service credit as a law enforcement, [or]
- 18 custodial, or peace officer is an amount computed on the basis of
- 19 the member's average monthly compensation for the 60 highest months
- 20 of compensation in the employee class, times the sum of the
- 21 percentage factor used in the computation of a standard service
- 22 retirement annuity under Section 814.105 plus .5 percent.
- 23 (c) The standard combined service retirement annuity that
- 24 is payable under this section is based on retirement on or after the
- 25 attainment of the normal retirement age, which for purposes of this
- 26 section is the earlier of either the age of 57 or the age at which
- 27 the sum of the member's age and amount of service credit in the

- 1 employee class equals the number 80. The annuity of a law
- 2 enforcement, [or peace officer who retires before
- 3 reaching the age of 57 under any eligibility criteria is
- 4 actuarially reduced by five percent for each year of difference
- 5 between the member's age at retirement and 57. The actuarial
- 6 reduction described by this section is in addition to any other
- 7 actuarial reduction required by law.
- 8 (c-1) A law enforcement, [or custodial, or peace officer
- 9 who retires before attaining the age of 50 is entitled only to an
- 10 annuity that is actuarially reduced from the annuity available at
- 11 the age of 50 to the law enforcement, [ex] custodial, or peace
- 12 officer whose service credit annuity amount is based on the sum of
- 13 the member's age and amount of law enforcement, [ex] custodial, or
- 14 peace officer service credit and employee class service credit, and
- 15 is not entitled to have the annuity recalculated at normal
- 16 retirement age. The standard or reduced annuity under this section
- 17 is payable from the trust fund established by Section 815.310 and
- 18 the law enforcement, [and] custodial, and peace officer
- 19 supplemental retirement fund in a ratio determined by the
- 20 retirement system.
- 21 (d) A member who retires under this section retires
- 22 simultaneously from the employee class of membership. Optional
- 23 retirement annuities provided by Section 814.108 are available to a
- 24 member eligible to receive a service retirement annuity under this
- 25 section, but the same optional plan and beneficiary must be
- 26 selected for the portion of the annuity payable from the law
- 27 enforcement, [and] custodial, and peace officer supplemental

- 2 established by Section 815.310.
- 3 (e) The amount payable from the law enforcement, [and]
- 4 custodial, and peace officer supplemental retirement fund is
- 5 reducible by the amount paid from the trust fund established by
- 6 Section 815.310 for service as a law enforcement, [or] custodial,
- 7 or peace officer. The total combined amount of an annuity under
- 8 this section may not be less than the authorized benefit under
- 9 Subsection (b) subtracted by any amount necessary because of
- 10 selection of an optional annuity, because of retirement before the
- 11 normal retirement age, or as provided by Subsection (f).
- 12 (f) The standard combined service retirement annuity
- 13 payable for at least 20 years of service credit as a law

- 15 percent of the average compensation computed under Subsection (b).
- 16 (g) For purposes of this section, service as a law
- 17 enforcement, [or] custodial, or peace officer is creditable as
- 18 provided by rule of the board of trustees or on a month-to-month
- 19 basis, whichever is greater.
- 20 SECTION 12. The heading to Section 814.207, Government
- 21 Code, is amended to read as follows:
- Sec. 814.207. DISABILITY RETIREMENT BENEFITS FOR CERTAIN
- 23 [PEACE] OFFICERS.
- SECTION 13. Section 814.207, Government Code, is amended by
- 25 amending Subsections (a) and (d) and adding Subsection (a-1) to
- 26 read as follows:
- 27 (a) This section applies only to a member who participates

- 1 in the law enforcement, custodial, and peace officer supplemental
- 2 retirement fund.
- 3 (a-1) An annuity payable for an occupational disability
- 4 resulting from a risk to which law enforcement, [or] custodial, or
- 5 peace officers are exposed because of the nature of their [law
- 6 enforcement or custodial duties is payable under the same terms
- 7 and conditions that apply to other occupational disability
- 8 retirement annuities under this subtitle, except that the source
- 9 and amount of the annuity are as provided by this section.
- 10 (d) The portions of the annuity under this section payable
- 11 from the law enforcement, [and] custodial, and peace officer
- 12 supplemental retirement fund are the amount remaining after
- 13 deduction of any amount payable under Section 814.206, except the
- 14 portion of an amount that exceeds the minimum payments provided by
- 15 Section 814.206(b) and that is made for service other than as a law
- 16 enforcement, [ex] custodial, or peace officer and any amount by
- 17 which an annuity is increased under Subsection (e).
- 18 SECTION 14. Section 814.305, Government Code, is amended to
- 19 read as follows:
- Sec. 814.305. ANNUITY FOR SURVIVOR OF LAW ENFORCEMENT, [OR]
- 21 CUSTODIAL, OR PEACE OFFICER. (a) This section applies only to a
- 22 member who participates in the law enforcement, custodial, and
- 23 peace officer supplemental retirement fund.
- (b) If a member who has at least 20 years of service credit
- 25 as a law enforcement, [or custodial, or peace officer dies, the
- 26 amount of the death benefit annuity payable for the member's
- 27 service as a law enforcement, [ex] custodial, or peace officer is an

- 1 amount computed and funded as provided by Section 814.107,
- 2 including any applicable reduction factors.
- 3 SECTION 15. Section 815.103(c), Government Code, is amended
- 4 to read as follows:
- 5 (c) The board of trustees may authorize the executive
- 6 director to acquire, hold, manage, purchase, sell, assign, trade,
- 7 transfer, and dispose of any security, evidence of debt, or other
- 8 investment in which assets of the law enforcement, [and] custodial,
- 9 and peace officer supplemental retirement fund may be invested.
- SECTION 16. Section 815.208(c), Government Code, is amended
- 11 to read as follows:
- 12 (c) The board of trustees shall make payments from the law
- 13 enforcement, [and] custodial, and peace officer supplemental
- 14 retirement fund for services rendered by the actuary for that fund
- 15 and approved by the board.
- SECTION 17. Sections 815.301(a) and (b), Government Code,
- 17 are amended to read as follows:
- 18 (a) The board of trustees shall:
- 19 (1) invest the assets of the retirement system as a
- 20 single fund without distinction as to their source; and
- 21 (2) hold securities purchased with the assets
- 22 described by Subsection (a)(1) collectively for the proportionate

- 24 (A) all accounts in the trust fund that are

- 26 (B) the law enforcement, [and] custodial, and

Subject to Section 815.3016, the board of 3 trustees or the executive director may, under the standard of care provided by Section 815.307, invest and reinvest any of the 5 retirement system's assets and may commingle assets of the trust 6 fund and the law enforcement, [and] custodial, and peace officer 7 8 supplemental retirement fund with the assets of the Judicial Retirement System of Texas Plan Two for investment purposes, as 9 long as proportionate ownership records are maintained and 10 credited. Investments may include home office facilities, 11 12 including land, equipment, and office building, used in 13 administering the retirement system.

- 21 long as proportionate ownership records are maintained and
- 22 credited.

- 26 under this section to the following accounts and funds so that each
- 27 receives to the extent practicable, utilizing historical data as
