Section 24.033(b), Government Code, is amended 4 5 to read as follows: 6 Notwithstanding any other law, if a disaster, as defined (b) by Section 418.004, occurs in a [first tier coastal] county [or a 7 second tier coastal county] that precludes a district court from 8 9 conducting its proceedings at the county seat of that county, the presiding judge of the administrative judicial region, with the 10 approval of the judge of the affected district court, may designate 11 12 for the proceedings an alternate location: 13 in the judicial district of the affected court; or (1) 14 (2) at the location outside the judicial district closest in proximity to the county seat that allows the court to 15 16 safely and reasonably [at which the court may] conduct its 17 proceedings. 18 SECTION 2. Section 25.0019(b), Government Code, is amended to read as follows: 19 Notwithstanding any other law, including a specific 20 (b) provision in this chapter for a particular court or county that 21 requires a statutory county court to conduct its proceedings at the 22 23 county seat, if a disaster, as defined by Section 418.004, occurs in a [first tier coastal] county [or a second tier coastal county] that 24

1 precludes a statutory county court in that county from conducting 2 its proceedings at the county seat, the presiding judge of the 3 administrative judicial region, with the approval of the judge of 4 the affected statutory county court, may designate <u>for the</u> 5 <u>proceedings</u> an alternate location:

(1) in the county; or

7 (2) at the location outside the county closest in 8 proximity to the county seat that allows the court to safely and 9 reasonably [at which the court may] conduct its proceedings.

10 SECTION 3. Section 26.009(b), Government Code, is amended 11 to read as follows:

12 (b) Notwithstanding any other law, including Section 26.002(c), if a disaster, as defined by Section 418.004, occurs in a 13 14 [first tier coastal] county [or a second tier coastal county] that precludes the county court from conducting its proceedings at the 15 county seat, the presiding judge of the administrative judicial 16 17 region, with the approval of the judge of the affected county court, may designate for the proceedings an alternate location: 18

(1) in the county; or

20 (2) at the location outside the county closest in 21 proximity to the county seat that allows the court to safely and 22 reasonably [at which the court may] conduct its proceedings.

23 SECTION 4. Sections 24.033(a), 25.0019(a), and 26.009(a), 24 Government Code, are repealed.
