No. 2687 1 Services Commission; 2 one representative of an institution of (H) 3 higher education; 4 (I) one representative of the Texas Workforce 5 Commission civil rights division; 6 (J) one representative of the Texas Workforce 7 Commission division of workforce development; and 8 (K) one representative of a nonprofit 9 organization dedicated to civil rights; 10 (2) two members appointed by the lieutenant governor as follows: 11 12 (A) a parent or guardian of a person who is transgender; and 13 14 (B) an attorney who specializes in transgender 15 rights; and 16 (3) two members appointed by the speaker of the house 17 of representatives as follows: 18 (A) a physician who specializes in transgender health issues; and 19 20 one person who is transgender. (B) The task force shall hold its first meeting not later 21 (d) than October 1, 2019, and shall elect a presiding officer from among 22 its membership. The task force shall hold subsequent meetings at 23 24 least quarterly at the call of the presiding officer. 25 (e) A task force member is not entitled to compensation for 26 service on the task force but is entitled to reimbursement for

The task force may accept gifts, grants, and donations to pay for those expenses. 2 The Texas Workforce Commission civil rights division 3 (f) shall provide administrative support services at the request of the 4 5 task force. 6 (g) The task force shall study how to ensure equality and 7 improve the lives of persons who are transgender, with particular 8 attention to the following areas: health care, including access to health care 9 (1)providers who are trained in transgender medical issues; (2) long-term care for persons who are transgender and chronically ill or of advanced age; (3) education; 14 (4) higher education; (5) housing, including homelessness prevention and reduction; (6) employment; and criminal justice, including the following: (7)(A) raising transgender awareness among law enforcement through training; and facilitating the appropriate placement of (B) persons who are transgender in correctional facilities based on a person's gender identity. 24 (h) A state agency shall cooperate with and assist the task force in carrying out the duties of the task force. 25 Not later than December 1, 2020, the task force shall 26 (i) prepare and submit to the governor and the legislature a written 27

1 report that summarizes the task force's findings under this section 2 and recommends solutions for advancing transgender equality and 3 improving the lives of persons in this state who are transgender.

4 (j) The task force is abolished and this Act expires5 September 1, 2021.

## 6 SECTION 2. This Act takes effect September 1, 2019.
