Sections 402.104(a) and (d), Occupations Code, are amended to read as follows: 6 7 (a) The department shall develop and maintain an examination that may include <u>a</u> written [, oral,] or practical <u>test</u> 8 [tests]. The department shall administer or arrange for the 9 administration and validation of the examination. 10 11 (d) The practical test [examination] must be administered 12 by one or more qualified proctors selected and assigned by the department. 13 14 SECTION 2. Section 402.204(a), Occupations Code, is amended to read as follows: 15 The examination must consist of written and [, oral, or] 16 (a) practical tests that are objective in method and applied in a 17 18 consistent manner. SECTION 3. Section 402.205, Occupations Code, is amended by 19 amending Subsections (a) and (c) and adding Subsection (d) to read 20 21 as follows: 22 (a) The department or the department's authorized 23 representative shall give each applicant due notice of the date and 24 place of the examination and the subjects, areas, and skills that

1 will be included in the examination. A change may not be made in those subjects, areas, and skills after the date of the examination 2 3 has been announced and publicized.

4 An [On reexamination, an] applicant who previously (c) failed an examination or test may retake the examination or test. 5

6 (d) An applicant who previously failed a practical test may 7 be retested [examined] only on those portions of the practical test [examination] that the applicant failed. 8

9 SECTION 4. Section 402.207(a), Occupations Code, is amended to read as follows: 10

The department shall issue an apprentice permit to fit 11 (a) 12 and dispense hearing instruments to a temporary training permit holder who has: 13

14

(1)passed the required [all parts of the] examination 15 [with a score of 70 percent or greater];

16

paid the required fees; and (2)

17 (3) met all requirements of this chapter.

SECTION 5. Sections 402.209(e) and (f), Occupations Code, 18 are amended to read as follows: 19

20 (e) If the department approves an application, [on the next regularly scheduled examination date] the applicant may take the 21 practical test [section of the examination required under Section 22 23 402.202] and a written test [examination] of Texas law administered 24 by the department or the department's authorized representative. [If the applicant passes the examinations required under this 25 26 section, the department shall issue to the applicant a license under this chapter.] 27

1 (f) The department may allow an applicant under this section 2 who satisfies all application requirements other than the 3 requirement under Subsection (c)(2) to take [all sections of] the 4 examination [required under Section 402.202. If the applicant 5 passes the examination, the department shall issue to the applicant 6 a license under this chapter].

7 SECTION 6. The following provisions of the Occupations Code 8 are repealed:

9

(1) Sections 402.104(b) and (c); and

10 (2) Section 402.203(c).

SECTION 7. The changes in law made by this Act to Chapter 402, Occupations Code, apply only to a person who applies to take an examination on or after the effective date of this Act. A person who first applies to take an examination before the effective date of this Act is governed by the law in effect on the date the person applies, and the former law is continued in effect for that purpose. SECTION 8. This Act takes effect September 1, 2019.
