- 9 [tests]. The department shall administer or arrange for the

- 9 SECTION 4. Section 402.207(a), Occupations Code, is amended
- 10 to read as follows:
- 11 (a) The department shall issue an apprentice permit to fit
- 12 and dispense hearing instruments to a temporary training permit
- 13 holder who has:
- 14 (1) passed the required [all parts of the] examination
- 15 [with a score of 70 percent or greater];
- 16 (2) paid the required fees; and
- 17 (3) met all requirements of this chapter.
- SECTION 5. Sections 402.209(e) and (f), Occupations Code,
- 19 are amended to read as follows:
- 20 (e) If the department approves an application, [on the next
- 21 regularly scheduled examination date] the applicant may take the
- 22 practical test [section of the examination required under Section
- 23 $\frac{402.202}{}$ and a written $\frac{\text{test}}{}$ [examination] of Texas law administered

(f) The department may allow an applicant under this section who satisfies all application requirements other than the requirement under Subsection (c)(2) to take [all sections of] the examination [required under Section 402.202. If the applicant passes the examination, the department shall issue to the applicant a license under this chapter].

- 7 SECTION 6. The following provisions of the Occupations Code 8 are repealed:
- 9 (1) Sections 402.104(b) and (c); and
- 10 (2) Section 402.203(c).
- SECTION 7. The changes in law made by this Act to Chapter 402, Occupations Code, apply only to a person who applies to take an examination on or after the effective date of this Act. A person who first applies to take an examination before the effective date of this Act is governed by the law in effect on the date the person applies, and the former law is continued in effect for that purpose.

 SECTION 8. This Act takes effect September 1, 2019.
