A BILL TO BE ENTITLED 1 AN ACT 2 relating to the use of hotel occupancy tax revenue by certain municipalities, including the authority to pledge certain revenue 3 for the payment of obligations related to hotel projects. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Section 351.101, Tax Code, is amended by adding 7 Subsection (q) to read as follows: (q) In addition to the purposes provided by Subsections (a) 8 9 and (e), a municipality described by Section 351.102(e)(13) may use revenue from the hotel occupancy tax for the construction, 10 improvement, enlarging, equipping, renovating, repairing, 11 operation, and maintenance of a coliseum or multiuse facility and 12 related infrastructure or a venue, as defined by Section 13 14 334.001(4), Local Government Code, that is related to the promotion of tourism, including a hotel, resort, or convention center 15 16 facility located on land owned by the municipality or a nonprofit corporation acting on behalf of the municipality. 17 SECTION 2. Sections 351.102(e) and (g), Tax Code, are 18 amended to read as follows: 19 20 In addition to the municipalities described (e) by 21 Subsection (b), that subsection also applies to: (1) a municipality with a population of at least 22

No. 2788 1 (2) a municipality with a population of at least 9,000 but not more than 10,000 that is located in two counties, each of 2 which has a population of at least 662,000 and a southern border 3 with a county with a population of 2.3 million or more; 4 5 (3) a municipality with a population of at least 6 200,000 but not more than 300,000 that contains a component institution of the Texas Tech University System; 7 (4) a municipality with a population of at 8 least 95,000 that borders Lake Lewisville; 9 10 (5) a municipality that: contains a portion of Cedar Hill State Park; 11 (A) 12 (B) has a population of more than 45,000; is located in two counties, one of which has a 13 (C) population of more than two million and one of which has a 14 15 population of more than 149,000; and 16 (D) has adopted a capital improvement plan for 17 the construction or expansion of a convention center facility; (6) a municipality with a population of less than 18 6,000 that: 19 (A) is located in two counties each with a 20 population of 600,000 or more that are both adjacent to a county 21 with a population of two million or more; 22 23 (B) has full-time police and fire departments; 24 and 25 (C) has adopted a capital improvement plan for 26 the construction or expansion of a convention center facility; 27 (7) a municipality with a population of at least

7	(g) A municipality to which this section applies may not
8	receive or pledge revenue or funds under Subsection (b) or (c) for a
9	hotel project unless the municipality enters into an agreement with
10	a person for the development of the hotel project before September
11	1, <u>2021</u> [2019].
12	SECTION 3. This Act takes effect immediately if it receives
13	a vote of two-thirds of all the members elected to each house, as
14	provided by Section 39, Article III, Texas Constitution. If this
15	Act does not receive the vote necessary for immediate effect, this

16 Act takes effect September 1, 2019.
