## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the statewide behavioral health coordinating council.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Chapter 531, Government Code, is amended by
5	adding Subchapter M-1 to read as follows:
6	SUBCHAPTER M-1. STATEWIDE BEHAVIORAL HEALTH COORDINATING COUNCIL
7	Sec. 531.471. DEFINITION. In this subchapter, "council"
8	means the statewide behavioral health coordinating council.
9	Sec. 531.472. PURPOSE. The council is established to
10	ensure a strategic statewide approach to behavioral health
11	services.
12	Sec. 531.473. COMPOSITION OF COUNCIL. (a) The council is
13	composed of at least one representative designated by each of the
14	following entities:
15	(1) the governor's office;
16	(2) the Texas Veterans Commission;
17	(3) the commission;
18	(4) the Department of State Health Services;
19	(5) the Department of Family and Protective Services;
20	(6) the Texas Civil Commitment Office;
21	(7) The University of Texas Health Science Center at
22	Houston;
23	(8) The University of Texas Health Science Center at
24	<pre>Tyler;</pre>

1	(9) the Texas Tech University Health Sciences Center;
2	(10) the Texas Department of Criminal Justice;
3	(11) the Texas Correctional Office on Offenders with
4	Medical or Mental Impairments;
5	(12) the Commission on Jail Standards;
6	(13) the Texas Indigent Defense Commission;
7	(14) the court of criminal appeals;
8	(15) the Texas Juvenile Justice Department;
9	(16) the Texas Military Department;
10	(17) the Texas Education Agency;
11	(18) the Texas Workforce Commission;
12	(19) the Health Professions Council, representing:
13	(A) the State Board of Dental Examiners;
14	(B) the Texas State Board of Pharmacy;
15	(C) the State Board of Veterinary Medical
16	<pre>Examiners;</pre>
17	(D) the Texas Optometry Board;
18	(E) the Texas Board of Nursing; and
19	(F) the Texas Medical Board; and
20	(20) the Texas Department of Housing and Community
21	Affairs.
22	(b) The executive commissioner shall determine the number
23	of representatives that each entity may designate to serve on the
24	<pre>council.</pre>
25	(c) The council may authorize another state agency or
26	institution that provides specific behavioral health services with
27	the use of appropriated money to designate a representative to the

- 2 (d) A council member serves at the pleasure of the
- 3 designating entity.
- 4 Sec. 531.474. PRESIDING OFFICER. The mental health
- 5 statewide coordinator shall serve as the presiding officer of the
- 6 council.
- 7 Sec. 531.475. MEETINGS. The council shall meet at least
- 8 once quarterly or more frequently at the call of the presiding
- 9 officer.
- 10 Sec. 531.476. POWERS AND DUTIES. The council:
- 11 (1) shall develop and monitor the implementation of a
- 12 five-year statewide behavioral health strategic plan;
- (2) shall develop a biennial coordinated statewide
- 14 behavioral health expenditure proposal;
- 15 (3) shall annually publish an updated inventory of
- 16 behavioral health programs and services that are funded by the
- 17 state that includes a description of how those programs and
- 18 services further the purpose of the statewide behavioral health
- 19 strategic plan;
- 20 (4) may create subcommittees to carry out the
- 21 <u>council's duties under this subchapter; and</u>
- 22 (5) may facilitate opportunities to increase
- 23 <u>collaboration</u> for the effective expenditure of available federal
- 24 and state funds for behavioral and mental health services in this
- 25 state.
- 26 SECTION 2. This Act takes effect immediately if it receives
- 27 a vote of two-thirds of all the members elected to each house, as

- 1 provided by Section 39, Article III, Texas Constitution. If this
- 2 Act does not receive the vote necessary for immediate effect, this
- 3 Act takes effect September 1, 2019.
