9 (11) the status of any environmental review of the 10 project;

(12) detailed instructions for preparing the technical proposal required under Subsection (d), including a description of the form and level of completeness of drawings expected;

(13) the relative weighting of the technical and cost proposals required under Subsection (d) and the formula by which the proposals will be evaluated and ranked; and

18 (14) the criteria to be used in evaluating the19 technical proposals, and the relative weighting of those criteria.

20 SECTION 3. Section 223.246(a), Transportation Code, as 21 amended by this Act, applies only to a highway project for which a request for qualifications is issued on or after the effective date 22 A highway project for which a request for 23 of this Act. 24 qualifications is issued before the effective date of this Act is governed by the law in effect on the date the request for 25 26 qualifications was issued, and that law is continued in effect for 27 that purpose.
