 $\,$ (12) knowingly makes, uses, or causes the making or use of a false record or statement to conceal, avoid, or decrease an obligation to pay or transmit money or property to this state $\underline{\text{or the}}$ $\underline{\text{federal government}}$ under $\underline{\text{a health care}}$ [the Medicaid] program.

An offense under this section is:

- a Class C misdemeanor if the amount of any payment (1)or the value of any monetary or in-kind benefit provided or claim for payment made under <u>a health care</u> [$\frac{\text{the Medicaid}}{\text{modirectly}}$] program, directly or indirectly, as a result of the conduct is less than \$100;
- a Class B misdemeanor if the amount of any payment (2) or the value of any monetary or in-kind benefit provided or claim for payment made under <u>a health care</u> [$\frac{\text{the Medicaid}}{\text{moder}}$] program, directly or indirectly, as a result of the conduct is \$100 or more but less than \$750;
- (3) a Class A misdemeanor if the amount of any payment or the value of any monetary or in-kind benefit provided or claim for payment made under <u>a health care</u> [$\frac{\text{the Medicaid}}{\text{modificate}}$] program, directly or indirectly, as a result of the conduct is \$750 or more but less than \$2,500;

(4) a state jail felony if:
(A) the amount of any payment or the value of any monetary or in-kind benefit provided or claim for payment made

(C) it is shown on the trial of the offense that the amount of the payment or value of the benefit described by this subsection cannot be reasonably ascertained;

a felony of the third degree if:

- (A) the amount of any payment or the value of any monetary or in-kind benefit provided or claim for payment made under a health care [the Medicaid] program, directly or indirectly, as a result of the conduct is \$30,000 or more but less than \$150,000; or
- (B) it is shown on the trial of the offense that the defendant submitted more than 25 but fewer than 50 fraudulent claims under a health care [the Medicaid] program and the submission of each claim constitutes conduct prohibited by Subsection (a);

a felony of the second degree if:

- (A) the amount of any payment or the value of any in-kind benefit provided or claim for payment made monetary or under a health care [the Medicaid] program, directly or indirectly, as a result of the conduct is \$150,000 or more but less than \$300,000; or
- (B) it is shown on the trial of the offense that the defendant submitted 50 or more fraudulent claims under a health <u>care</u> [the Medicaid] program and the submission of each claim constitutes conduct prohibited by Subsection (a); or
- (7) a felony of the first degree if the amount of any payment or the value of any monetary or in-kind benefit provided or claim for payment made under a health care [the Medicaid] program, directly or indirectly, as a result of the conduct is \$300,000 or
- (c) If conduct constituting an offense under this section also constitutes an offense under another section of this code or another provision of law, the actor may be prosecuted under either this section or the other section or provision or both this section and the other section or provision.
- When multiple payments or monetary or in-kind benefits (d) are provided under one or more health care programs [the Medicaid program] as a result of one scheme or continuing course of conduct, the conduct may be considered as one offense and the amounts of the payments or monetary or in-kind benefits aggregated in determining the grade of the offense.
- The punishment prescribed for an offense under (e) this section, other than the punishment prescribed by Subsection (b)(7), is increased to the punishment prescribed for the next highest category of offense if it is shown beyond a reasonable doubt on the trial of the offense that the actor was a [provider or] high managerial agent at the time of the offense.
- With the consent of the appropriate local county or (f) district the attorney general has concurrent attorney, jurisdiction with that consenting local prosecutor to prosecute an offense under this section that involves <u>a health care</u> Medicaid program.

SECTION 7. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. purposes of this section, an offense was committed before the effective date of this Act if any element of the offense occurred before that date.

SECTION 8. This Act takes effect September 1, 2019.
