## A BILL TO BE ENTITLED

- 2 relating to hospital liens.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Chapter 55, Property Code, is amended by adding
- 5 Section 55.0015 to read as follows:
- 6 Sec. 55.0015. ADMISSION TO HOSPITAL. For purposes of this
- 7 chapter, an injured individual is considered admitted to a hospital
- 8 if the individual is allowed access to any department of the
- 9 hospital for the provision of any treatment, care, or service to the
- 10 individual.
- SECTION 2. Sections 55.004(b) and (d), Property Code, are
- 12 amended to read as follows:
- 13 (b) A hospital lien described by Section 55.002(a) is for
- 14 the lesser of:
- 15 (1) the amount of the hospital's charges for services
- 16 provided to the injured individual during the first 100 days of the
- 17 injured individual's hospitalization; or
- 18 (2) 50 percent of all amounts recovered by the injured
- 19 individual through a cause of action, judgment, or settlement
- 20 described by Section 55.003(a).
- 21 (d) A hospital lien described by Section 55.002(a) does not
- 22 cover:
- 23 (1) charges for other services that exceed a
- 24 reasonable and regular rate for the services;

- 1 (2) charges by the physician related to any services
- 2 provided under Subsection (c) for which the physician has accepted
- 3 insurance benefits or payment under a private medical indemnity
- 4 plan or program, regardless of whether the benefits or payment
- 5 equals the full amount of the physician's charges for those
- 6 services;
- 7 (3) charges by the physician for services provided
- 8 under Subsection (c) if the injured individual has coverage under a
- 9 private medical indemnity plan or program from which the physician
- 10 is entitled to recover payment for the physician's services under
- 11 an assignment of benefits or similar rights; [or]
- 12 (4) charges by the physician related to any services
- 13 provided under Subsection (c) if the physician is a member of the
- 14 legislature; or
- 15 (5) charges for which recovery is barred under Section
- 16 146.003, Civil Practice and Remedies Code.
- 17 SECTION 3. The addition by this Act of Section 55.0015,
- 18 Property Code, is intended to clarify rather than change the
- 19 existing law.
- 20 SECTION 4. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2019.
