Sec. 786.004. CLAIM OR DEFENSE BASED ON ADVERSE EMPLOYMENT ACTION; DAMAGES. (a) A person may assert a violation of this chapter as a claim against an employer, including a governmental entity, in a judicial or administrative proceeding or as a defense in a judicial or administrative proceeding.

12 (b) An aggrieved person may seek:

13 (1) compensatory damages;

14 (2) reasonable attorney's fees and court costs; and

15 (3) any other appropriate relief.

16 <u>Sec. 786.005. SOVEREIGN IMMUNITY WAIVED.</u> Sovereign 17 immunity to suit is waived and abolished to the extent of liability 18 <u>created by this chapter.</u>

SECTION 2. This Act applies only to a 19 suspension, termination, or other adverse employment action taken by an 20 21 employer against a first responder on or after the effective date of this Act. A suspension, termination, or other adverse employment 22 23 action that is taken by an employer against a first responder before 24 the effective date of this Act is governed by the law in effect on the date the employment action is taken, and the former law is 25 26 continued in effect for that purpose.

27 SECTION 3. This Act takes effect September 1, 2019.
