No. 2971 (2) a state employee is entitled to authorize a 1 deduction for contributions to the land office for the purposes of 2 managing the Save Texas History and Adopt-A-Beach programs as a 3 charitable contribution under Section 659.132, Government Code, 4 5 and the land office may use the contributions for the purpose of: 6 (A) preserving historic maps and documents under 7 the Save Texas History program; or 8 (B) administering the Adopt-A-Beach program. 9 (b) The land office may use cash, gifts, grants, donations, or in-kind contributions the land office receives through the 10 administration of the Save Texas History program to: 11 12 (1) preserve, conserve, and promote the land office's 13 records; 14 (2) provide educational programming and resources on 15 Texas history; and 16 (3) acquire additional records to complement the land 17 office's records. SECTION 3. This Act takes effect immediately if it receives 18 a vote of two-thirds of all the members elected to each house, as 19 provided by Section 39, Article III, Texas Constitution. If this 20 21 Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019. 22
