## A BILL TO BE ENTITLED

AN ACT

2	relating to student data security in public schools.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Chapter 32, Education Code, is amended by adding
5	Subchapter E to read as follows:
6	SUBCHAPTER E. STUDENT DATA SECURITY
7	Sec. 32.201. DEFINITION. In this subchapter, "data breach'
8	means an incident in which student information that is sensitive,
9	protected, or confidential, as provided by state or federal law, is
10	stolen or is copied, transmitted, viewed, or used by a persor
11	unauthorized to engage in that action.
12	Sec. 32.202. REPORTING OF STUDENT DATA BREACH. (a)
13	school district shall provide written notice to a parent of or
14	person standing in parental relation to a student enrolled in the
15	district of a school district data breach involving the student's
16	information not later than the 30th day after the date on which the
17	district becomes aware of the data breach. The notice must include:
18	(1) a description of the type of information that was
19	the subject of the data breach; and
20	(2) a general description of any action taken or
21	planned to be taken by the district to:
22	(A) reduce damage as a result of the data breach;
23	<u>or</u>
24	(B) prevent another data breach, including

- 2 (b) A school district shall submit to the agency a report on
- 3 a school district data breach not later than the 60th day after the
- 4 date the district becomes aware of the data breach. The report must
- 5 include:
- 6 (1) detailed information regarding the nature of the

- 8 (2) the number of students affected by the data
- 9 breach;
- 10 (3) a description of the type of information that was
- 11 the subject of the data breach; and
- 12 (4) a detailed description of any action taken or
- 13 planned to be taken by the district to:
- 14 (A) reduce damage as a result of the data breach;
- 15 <u>or</u>
- 16 (B) prevent another data breach, including
- 17 adopting a student privacy pledge.
- 18 (c) Information reported under Subsection (b)(1) or (4) is
- 19 confidential and not subject to disclosure under Chapter 552,
- 20 Government Code.
- Sec. 32.203. STUDENT DATA BREACH DATABASE. (a) The agency
- 22 <u>shall establish and maintain an electronically searchable database</u>
- 23 that contains information regarding each school district data
- 24 breach reported under Section 32.202(b).
- 25 (b) The database must contain the following publicly
- 26 accessible information for each school district data breach:
- 27 (1) the school district at which the data breach

- 1 occurred; and
- 2 (2) the number of students affected by the data
- 3 breach.
- 4 (c) The database must also contain for each school district
- 5 data breach the information reported under Sections 32.202(b)(1)
- 6 and (4). The agency shall ensure that only a school administrator
- 7 may access information contained in the database under this
- 8 subsection.
- 9 Sec. 32.204. RULES. The commissioner may adopt rules as
- 10 necessary to implement this subchapter.
- SECTION 2. Section 12.104(b), Education Code, as amended by
- 12 Chapters 324 (S.B. 1488), 522 (S.B. 179), and 735 (S.B. 1153), Acts
- 13 of the 85th Legislature, Regular Session, 2017, is reenacted and
- 14 amended to read as follows:
- 15 (b) An open-enrollment charter school is subject to:
- 16 (1) a provision of this title establishing a criminal
- 17 offense; and
- 18 (2) a prohibition, restriction, or requirement, as
- 19 applicable, imposed by this title or a rule adopted under this
- 20 title, relating to:

- 12 SECTION 3. To the extent of any conflict, this Act prevails
- 13 over another Act of the 86th Legislature, Regular Session, 2019,
- 14 relating to nonsubstantive additions to and corrections in enacted
- 15 codes.
- SECTION 4. This Act takes effect immediately if it receives
- 17 a vote of two-thirds of all the members elected to each house, as
- 18 provided by Section 39, Article III, Texas Constitution. If this
- 19 Act does not receive the vote necessary for immediate effect, this
- 20 Act takes effect September 1, 2019.
