## A BILL TO BE ENTITLED

<u>L</u>	AN ACT

- 2 relating to the Texas college work-study program and to
- 3 establishing a program for the off-campus employment of certain
- 4 students at public or private institutions of higher education.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. The heading to Section 56.076, Education Code,
- 7 is amended to read as follows:
- 8 Sec. 56.076. <u>EMPLOYMENT UNDER PROGRAM</u> [<u>ELICIBLE EMPLOYER</u>].
- 9 SECTION 2. Section 56.076(a), Education Code, is amended to
- 10 read as follows:
- 11 (a) An eligible institution may employ eligible students
- 12 [enter into agreements with employers that participate] in the
- 13 work-study program. To be eligible to participate in the
- 14 work-study program, an eligible institution [employer] must:
- 15 (1) provide [part-time] employment to an eligible
- 16 student in nonpartisan and nonsectarian activities;
- 17 (2) provide, insofar as is practicable, employment to
- 18 an eligible student that is related to the student's academic
- 19 interests;
- 20 (3) use Texas college work-study program positions
- 21 only to supplement and not to supplant positions normally filled by
- 22 persons not eligible to participate in the work-study program;
- 23 (4) provide from sources other than federal college
- 24 work-study program funds a percentage of an employed student's

- 1 wages that is equal to the percentage of a student's wages that the
- 2 eligible institution [employer] would be required to provide to the
- 3 student in that academic year under the federal college work-study
- 4 program; and
- 5 (5) provide from sources other than federal college
- 6 work-study funds 100 percent of other employee benefits for the
- 7 employed student.
- 8 SECTION 3. Section 56.078, Education Code, is amended to
- 9 read as follows:
- 10 Sec. 56.078. FUNDING. Funding to cover the state's
- 11 contribution toward the funding of the work-study program under
- 12 this subchapter and the Texas WORKS internship program under
- 13 Subchapter E-1 is payable from funds appropriated for that purpose.
- 14 SECTION 4. Chapter 56, Education Code, is amended by adding
- 15 Subchapter E-1 to read as follows:
- 16 <u>SUBCHAPTER E-1. TEXAS WORKING OFF-CAMPUS: REINFORCING KNOWLEDGE</u>
- 17 AND SKILLS (WORKS) INTERNSHIP PROGRAM
- Sec. 56.0851. DEFINITIONS. In this subchapter:
- 19 (1) "Coordinating board" means the Texas Higher
- 20 Education Coordinating Board.
- 21 (2) "Eligible institution" means:
- 22 (A) an institution of higher education; or
- 23 (B) a private or independent institution of
- 24 higher education.
- 25 (3) "Eligible wages" means gross wages paid to an
- 26 individual student.
- 27 (4) "Private or independent institution of higher

- 1 <u>education" has the meaning assigned by Section 61.003.</u>
- 2 (5) "Program" or "Texas WORKS internship program"
- 3 means the Texas Working Off-Campus: Reinforcing Knowledge and
- 4 Skills (WORKS) Internship Program.
- 5 Sec. 56.0852. PROGRAM NAME. The student financial
- 6 assistance program authorized by this subchapter shall be known as
- 7 the Texas Working Off-Campus: Reinforcing Knowledge and Skills
- 8 (WORKS) Internship Program.
- 9 Sec. 56.0853. PURPOSE. The purpose of this subchapter is to
- 10 provide jobs funded in part by the State of Texas to enable students
- 11 to attend eligible institutions, explore career options, and
- 12 strengthen marketable skills.
- 13 Sec. 56.0854. ADMINISTRATIVE AUTHORITY. (a) The
- 14 coordinating board shall administer the program and collaborate
- 15 with participating employers to provide students with employment
- 16 <u>funded in part by the state.</u>
- (b) State support for the program may not exceed the amount
- 18 specified by appropriation.
- 19 (c) The coordinating board shall establish criteria to
- 20 ensure that:
- 21 (1) each participating employer has demonstrated the
- 22 administrative and financial capacity to carry out the employer's
- 23 responsibilities under the program, including the ability to pay
- 24 full wages and benefits to a student employed through the program;
- 25 (2) each participating employer is reimbursed under
- 26 the program at the contracted rate only for eligible wages paid in
- 27 full to a participating student; and

- 1 (3) the marketable skills to be strengthened or gained
- 2 through internships under the program have been identified.
- 3 (d) The coordinating board shall develop a standard
- 4 contract establishing the roles and responsibilities of
- 5 participating employers, including base wages, minimum work hours,
- 6 and any other provision necessary to carry out the purposes of this
- 7 subchapter. The coordinating board shall use the standard contract
- 8 as a model for the memorandum of understanding that the
- 9 coordinating board will require for participation in the program.
- 10 (e) The coordinating board shall reimburse a participating
- 11 employer at the contracted rate for the eligible wages paid by the
- 12 employer to a student participating in the program.
- 13 (f) The coordinating board may use funds appropriated for
- 14 the Texas college work-study program and the Texas WORKS internship
- 15 program to establish and maintain an online portal for use by
- 16 students and participating entities in fulfilling their
- 17 responsibilities for participation in the Texas WORKS internship
- 18 program. The coordinating board may use funds appropriated for the
- 19 Texas college work-study program and the Texas WORKS internship
- 20 program to cover the expenses and personnel costs of administering
- 21 and assessing this program.
- 22 (g) If funding for the program is insufficient to cover the
- 23 cost of all students seeking to participate in the program,
- 24 priority for funding is based on the criteria established by
- 25 coordinating board rules.
- 26 (h) Funds received by students as eligible wages under the
- 27 program are not considered as financial aid for the academic year in

- 1 which they are earned.
- 2 Sec. 56.0855. PARTICIPATING EMPLOYER. (a) The
- 3 coordinating board may enter into agreements with employers that
- 4 participate in the program.
- 5 (b) To be eligible to enter into an agreement with the
- 6 coordinating board to participate in the program, an employer must:
- 7 (1) be a private nonprofit or for-profit entity or a
- 8 governmental entity, other than an eligible institution or a career
- 9 school or college as defined by Section 132.001;
- 10 (2) enter into a memorandum of understanding with the
- 11 coordinating board;
- 12 (3) provide employment to a student in nonpartisan and
- 13 nonsectarian activities that relate to the student's long-term
- 14 career interests;
- 15 (4) use program positions only to supplement and not
- 16 to supplant positions normally filled by persons not eligible to
- 17 participate in the program;
- 18 (5) provide the entirety of an employed student's
- 19 wages and employee benefits;
- 20 (6) submit only eligible wages to the coordinating
- 21 board for reimbursement;
- 22 (7) meet the criteria for participating as established
- 23 by the coordinating board; and
- 24 (8) comply with other requirements adopted by the
- 25 coordinating board under this section.
- Sec. 56.0856. ADOPTION AND DISTRIBUTION OF RULES. (a) The
- 27 coordinating board shall adopt reasonable rules, consistent with

- 1 the purposes and policies of this subchapter, to enforce the
- 2 requirements, conditions, and limitations provided by this
- 3 subchapter.
- 4 (b) The coordinating board shall adopt rules necessary to
- 5 ensure compliance with the Civil Rights Act of 1964, Title VI (Pub.
- 6 L. No. 88-352), concerning nondiscrimination in admissions or
- 7 employment.
- 8 Sec. 56.0857. ONLINE LIST OF TEXAS WORKS EMPLOYMENT
- 9 OPPORTUNITIES. The coordinating board shall:
- 10 (1) establish and maintain an online listing of Texas
- 11 WORKS internship program employment opportunities available to
- 12 students, sortable by department, as appropriate; and
- 13 (2) ensure that the list is easily accessible to the
- 14 public through a clearly identifiable link that appears in a
- 15 prominent place on the coordinating board's Internet website.
- Sec. 56.0858. BIENNIAL REPORT. Not later than January 1 of
- 17 each odd-numbered year, the coordinating board shall submit to each
- 18 standing legislative committee with primary jurisdiction over
- 19 higher education and post on the board's Internet website a report
- 20 on the Texas WORKS internship program. The report must include the
- 21 total number of students employed through the program,
- 22 <u>disaggregated by:</u>
- 23 (1) the location of the employment; and
- 24 (2) the employer's status as a for-profit or nonprofit
- 25 entity.
- SECTION 5. Section 56.076(b), Education Code, is repealed.
- 27 SECTION 6. (a) As soon as practicable after the effective

- 1 date of this Act, the commissioner of the Texas Higher Education
- 2 Coordinating Board shall develop the rules and procedures necessary
- 3 for the implementation of Subchapter E-1, Chapter 56, Education
- 4 Code, as added by this Act.
- 5 (b) The changes in law made by this Act apply beginning with
- 6 the 2020 summer session.
- 7 SECTION 7. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2019.
