- 7 SECTION 1. Subchapter J, Chapter 21, Education Code, is

- 9 Sec. 21.468. COMPUTER SCIENCE AND TECHNOLOGY APPLICATIONS
- 10 PROFESSIONAL DEVELOPMENT GRANT PROGRAM. (a) In this section,
- 11 "institution of higher education" has the meaning assigned by
- 12 <u>Section 61.003.</u>
- 13 <u>(b) The commissioner shall establish a competitive</u>
- 14 professional development grant program to encourage teachers to:
- 15 (1) obtain computer science certification; and
- 16 (2) continue professional development in coding,
- 17 computational thinking, and computer science education.
- (c) From funds appropriated for the purpose, the
- 19 commissioner shall make grants to eligible providers that offer:
- 20 (1) professional development for elementary school
- 21 and middle and junior high school teachers to ensure teachers
- 22 maintain a working knowledge of current computer industry standard
