FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 214 SUBCHAPTER A. GENERAL PROVISIONS Sec. 8060.0101. DEFINITIONS. In this chapter: (1) "Board" means the district's board of directors. Sec. 8060.0102. NATURE AND PURPOSES OF DISTRICT. (a) The district is a municipal utility district created under Section 59, Article XVI, Texas Constitution. (b) The district is created to accomplish the purposes of: (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution, that relate to the construction, acquisition, improvement, operation, or maintenance of macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads.
