9	Sec. 424.001. DEFINITIONS. In this chapter:
10	(1) "Dating violence" means abuse or violence, or a
11	threat of abuse or violence, against a person with whom the actor
12	has or has had a social relationship of a romantic or intimate
13	nature.
14	(2) "Department" means the Department of Public Safety
15	of the State of Texas.
16	(3) "Sexual assault" means sexual contact or
17	intercourse with a person without the person's consent, including
18	sexual contact or intercourse against the person's will or in a
19	circumstance in which the person is incapable of consenting to the
20	contact or intercourse.
21	(4) "Sexual harassment" means unwelcome, sex-based
22	verbal or physical conduct that:
23	(A) in the employment context, unreasonably
24	interferes with a person's work performance or creates an

1 intimidating, hostile, or offensive work environment; or 2 (B) in the education context, is sufficiently 3 severe, persistent, or pervasive that the conduct interferes with a student's ability to participate in or benefit from educational 4 programs or activities at a postsecondary educational institution. 5 6 (5) "Stalking" means a course of conduct directed at a 7 person that would cause a reasonable person to fear for the person's 8 safety or to suffer substantial emotional distress. Sec. 424.002. ONLINE REPORTING SYSTEM. (a) The department 9 shall develop and establish or contract with a third party to 10 develop and establish an online reporting system through which a 11 12 person may report to the department an allegation of sexual harassment, sexual assault, dating violence, or stalking committed 13 against or witnessed by the person on property owned or rented by 14 15 the state. (b) The online reporting system must enable a person to 16 report the alleged incident anonymously. 17 (c) The department shall maintain information from reports 18 19 under Subsection (a) on the department's generally accessible Internet website. The information on the website must be 20 searchable by location, governmental entity, and type of incident. 21 Sec. 424.003. RULES. The department shall adopt rules as 22 necessary to implement and enforce this chapter. 23 24 SECTION 2. Not later than January 1, 2020, the Department of Public Safety of the State of Texas shall develop and establish the 25 26 online reporting system required under Section 424.002, Government Code, as added by this Act. 27
