2	relating to the regulation of reroofing contractors; providing
3	administrative and civil penalties; authorizing fees; creating a
4	criminal offense; requiring an occupational registration.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Title 8, Occupations Code, is amended by adding
7	Chapter 1306 to read as follows:
8	CHAPTER 1306. TEXAS BOARD ON REROOFING CONTRACTORS
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 1306.001. SHORT TITLE. This chapter may be cited as
11	the Reroofing Contractor Registration Act.
12	Sec. 1306.002. PURPOSE AND LEGISLATIVE FINDINGS. (a) This
13	<pre>legislature finds that:</pre>
14	(1) there is a growing need to provide state residents
15	with safe, affordable, and well-constructed replacement roofs;
16	(2) the reroofing industry requires regulation to
17	ensure safe working conditions for its contractors and best
18	<pre>protections for reroofing consumers;</pre>
19	(3) statutes and rules in effect before September 1,
20	2019, were inadequate to:
21	(A) fully protect the consumer; and
22	(B) prevent the construction of poorly made
23	replacement roofs;
24	(4) there is a need for the state of Texas to oversee

- and register reroofing contractors and to regulate the reroofing

 construction industry.

 (b) The purposes of this chapter are to:

 (1) encourage the construction of safe roofing for

 state residents; and
- 6 (2) improve the general welfare and safety of purchasers and consumers of roofing construction.
- 8 <u>(c) This chapter shall be liberally construed to promote its</u>
 9 policies and accomplish its purposes.
- Sec. 1306.003. DEFINITIONS. In this chapter:
- 11 (1) "Board" means the Texas Board on Reroofing
- 12 Contractors.
- (2) "Executive director" means the executive director
- of the Texas Board on Reroofing Contractors.
- 15 (4) "Person" means an individual or business entity.
- 16 <u>(5) "Registered reroofing contractor" means a</u>
- 17 reroofing contractor who is registered under this chapter and who
- 18 holds a valid statement of registration number issued under this
- 19 chapter.
- 20 (6) "Reroofing contractor" means a person who:
- 21 (A) engages in repairing, recovering, or
- 22 <u>replacing existing roof coverings on residential or commercial</u>
- 23 structures; or
- 24 (B) solicits, advertises, or contracts to
- 25 repair, recover, or replace existing roof coverings on residential
- 26 or commercial structures.
- 27 (8) "Reroofing project" means a project to repair,

- 1 recover, or replace an existing roof covering on a residential or
- 2 commercial structure.
- 3 Sec. 1306.004. EXEMPTIONS. This chapter does not apply to:
- 4 (1) an owner of residential property or property
- 5 primarily used for agricultural purposes, or an employee of the
- 6 owner, who performs a reroofing project on the owner's property;
- 7 (2) an authorized employee or representative of the
- 8 United States government, this state, or a county, municipality, or
- 9 other political subdivision of this state acting in an official
- 10 capacity;
- 11 (3) the new construction of a residential or
- 12 commercial structure; or
- 13 (4) a person performing a minor repair of an existing
- 14 roof covering if the value of the repair does not exceed \$500.
- SUBCHAPTER B. POWERS AND DUTIES
- Sec. 1306.050. TEXAS BOARD ON REROOFING CONTRACTORS. (a)
- 17 The Texas Board on Reroofing Contractors shall consists of seven
- 18 members appointed by the governor as follows:
- 19 (1) four reroofing contractors;
- 20 (2) one county or municipal building official in this
- 21 state; and
- 22 (3) two members who represent the public.
- (b) Appointments to the board shall be made without regard
- 24 to the race, color, disability, sex, religion, age, or national
- 25 origin of the appointee.
- 26 (c) Members of the board serve three-year terms.
- Sec. 1306.051. GENERAL POWERS AND DUTIES. The board shall

- 1 <u>administer and enforce this chapter.</u>
- 2 Sec. 1306.052. RULES. (a) The board by rule shall:
- 3 (1) prescribe the requirements for the issuance and
- 4 renewal of a registration under this chapter;
- 5 (2) adopt a code of ethics for reroofing contractors;
- 6 <u>and</u>
- 7 (3) with respect to reroofing projects on property
- 8 located in an area for which the governor declares a state of
- 9 disaster under Chapter 418, Government Code, provide for:
- 10 (A) a temporary exception to the requirements of
- 11 this chapter; and
- 12 (B) the temporary recognition of reroofing
- 13 contractors licensed or registered in good standing in another
- 14 state.
- 15 (b) The board may adopt additional rules as necessary to
- 16 administer this chapter.
- Sec. 1306.053. FEES. (a) Except as provided by Subsection
- 18 (b), the board shall establish and collect reasonable and necessary
- 19 fees in amounts sufficient to cover the costs of administering this
- 20 chapter.
- 21 (b) The fees adopted under this chapter must include fees
- 22 for:
- 23 <u>(1) an initial application for registration, in an</u>
- 24 amount not to exceed \$250; and
- 25 (2) the renewal of a registration, in an amount not to
- 26 exceed \$100.
- Sec. 1306.054. REGISTRATION DATABASE. The board shall make

- 1 available on its Internet website a publicly accessible list of all
- 2 registered reroofing contractors who are in good standing. The list
- 3 must be searchable by name and location. The list must contain the
- 4 following for each registered reroofing contractor:
- 5 (1) the name, mailing address, and telephone number of
- 6 the reroofing contractor;
- 7 (2) the date of initial registration;
- 8 (3) information concerning the reroofing contractor's
- 9 insurance coverage, if reported by the reroofing contractor;
- 10 (4) a summary of any disciplinary action taken by the
- 11 board against the reroofing contractor; and
- 12 (5) any other information required by the board.
- 13 Sec. 1306.055. REGISTRATION VERIFICATION. (a) A county or
- 14 municipal building official may not grant or approve a building or
- 15 construction permit for a reroofing project unless the applicant
- 16 for the permit is:
- 17 (1) a registered reroofing contractor; or
- 18 (2) exempt from registration under this chapter.
- 19 (b) On request of a county or municipal building official,
- 20 the board shall verify the registration of an applicant described
- 21 by Subsection (a). The board shall establish a verification system
- 22 to ensure a timely response to a request for verification of a
- 23 <u>registration</u>.
- Sec. 1306.056. EXECUTIVE DIRECTOR AND STAFF. (a) The board
- 25 shall employ an executive director as the executive head of the
- 26 agency.
- 27 (b) The board may employ personnel as necessary to

- 1 administer this chapter. The board may determine the compensation
- 2 and duties of its employees and the terms of their employment.
- 3 SUBCHAPTER C. REGISTRATION REQUIREMENTS
- 4 Sec. 1306.101. REGISTRATION REQUIRED. (a) Unless the
- 5 person holds a registration issued under this chapter, a person may
- 6 not:
- 7 (1) perform or otherwise engage in a reroofing
- 8 project; or
- 9 (2) solicit, advertise, or contract to perform or
- 10 engage in a reroofing project.
- 11 (b) A registration under this chapter shall be issued in the
- 12 form of a statement of registration number.
- 13 (c) A registration issued under this chapter:
- 14 (1) is valid only with respect to the person named on
- 15 the registration; and
- 16 (2) authorizes the registration holder to operate as a
- 17 reroofing contractor.
- 18 (d) A person may obtain a registration for more than one
- 19 business entity. A registration is not transferable.
- Sec. 1306.102. EXEMPTION FROM REGISTRATION. (a) A person
- 21 is not required to be registered under this chapter if:
- 22 (1) subject to Subsection (b), the person is a sales
- 23 manager, project manager, or other person employed or otherwise
- 24 used by a registered reroofing contractor in the ordinary course of
- 25 the contractor's business if the person does not engage in
- 26 repairing, recovering, or replacing an existing roof covering; or
- 27 (2) the person engages in repairing, recovering, or

- 1 replacing an existing roof covering as an employee of or under
- 2 contract with a registered reroofing contractor and the person is
- 3 not involved in soliciting, advertising, or executing contracts for
- 4 the contractor.
- 5 (b) A person described by Subsection (a)(1) shall operate in
- 6 the name of the registered reroofing contractor. The reroofing
- 7 contractor is responsible for the conduct of that person in
- 8 complying with the requirements of this chapter.
- 9 Sec. 1306.103. APPLICATION FOR REGISTRATION. (a) Ar
- 10 applicant for registration shall submit an application to the board
- 11 on a form prescribed by the executive director.
- 12 (b) The application must be accompanied by:
- 13 (1) if the applicant is an individual, proof of the
- 14 applicant's identity;
- 15 (2) if the applicant is a business entity, proof of the
- 16 applicant's existence and confirmation of authority to conduct
- 17 business in this state under a certificate of status issued by the
- 18 secretary of state that is in good standing;
- 19 (3) proof of the mailing address and telephone number
- 20 of the applicant's residence or business location; and
- 21 (4) the application fee.
- Sec. 1306.104. ISSUANCE OF REGISTRATION; TERM. (a) The
- 23 board shall issue a registration to an applicant who complies with
- 24 the registration requirements of this chapter not later than the
- 25 14th day after the date the board receives the application.
- 26 (b) A registration is valid for two years from the date of
- 27 issuance and may be renewed before expiration in the manner

- 1 provided by Section 1306.105.
- 2 Sec. 1306.105. RENEWAL OF REGISTRATION. (a) To renew a
- 3 registration, a reroofing contractor shall submit an application
- 4 for renewal to the board on a form prescribed by the executive
- 5 director.
- 6 (b) The application must be accompanied by:
- 7 (1) documentation of any changes in the reroofing
- 8 contractor's information submitted to the board under Section
- 9 1306.103(b); and
- 10 (2) the renewal fee.
- 11 SUBCHAPTER D. PRACTICE BY REGISTRATION HOLDER
- 12 Sec. 1306.151. DISCLOSURE OF REGISTRATION NUMBER. (a) A
- 13 registered reroofing contractor shall include the contractor's
- 14 registration number in each:
- (1) contract for a reroofing project in the manner
- 16 provided by Section 1306.153; and
- 17 (2) advertisement for a reroofing service by the
- 18 contractor, including on each business card, flyer, or door card
- 19 and in each television, radio, social media, or newspaper
- 20 advertisement.
- 21 (b) Other than the inclusion of a registration number in the
- 22 manner prescribed by this section, a reroofing contractor may not
- 23 make any representation or statement regarding the effect of being
- 24 issued a registration under this chapter or the fact that the
- 25 contractor has been issued a registration under this chapter.
- Sec. 1306.152. CERTAIN PRACTICES RELATING TO INSURANCE
- 27 DEDUCTIBLES PROHIBITED. A registered reroofing contractor may not

- 1 advertise or promise to pay or rebate all or part of an insurance
- 2 deductible in connection with a reroofing project in violation of
- 3 Section 27.02, Business & Commerce Code.
- 4 Sec. 1306.153. CONTRACT FOR REROOFING PROJECT. (a) Before
- 5 engaging in a reroofing project, a registered reroofing contractor
- 6 must provide a written contract to the property owner that is signed
- 7 by the reroofing contractor or the contractor's designee and the
- 8 property owner.
- 9 (b) A written contract under Subsection (a) must include:
- 10 (1) the following statement printed in at least
- 11 12-point bold type: "The work to be performed under this contract
- 12 must commence not later than the 30th day after the date the
- 13 reroofing contractor collects an initial payment, unless a longer
- 14 period is agreed to in writing and signed by both parties to this
- 15 contract.";
- 16 (2) the reroofing contractor's contact information,
- 17 including physical address, e-mail address, and telephone number;
- 18 <u>(3) the reroofing contractor's policy regarding</u>
- 19 cancellation of the contract; and
- 20 (4) the reroofing contractor's registration number in
- 21 at least 12-point bold type in the following form: "Texas
- 22 Registered Reroofing Contractor Number (registration number)."
- 23 Sec. 1306.154. COMPLIANCE WITH OTHER LAW. (a) A registered
- 24 reroofing contractor shall comply with each applicable:
- 25 (1) building code adopted by this state or a political
- 26 subdivision of this state; and
- 27 (2) order, ordinance, or rule of a political

- 1 subdivision relating to the issuance of a permit for or the
- 2 performance of a reroofing project in the political subdivision.
- 3 (b) A registered reroofing contractor shall comply with
- 4 Chapter 58, Business & Commerce Code, during a natural disaster, as
- 5 that term is defined by Section 58.001, Business & Commerce Code.
- 6 (c) The registered reroofing contractor's contract
- 7 cancellation policy must be consistent with state law.
- 8 SUBCHAPTER E. ENFORCEMENT
- 9 Sec. 1306.201. INVESTIGATION OF COMPLAINTS. (a) The board
- 10 shall investigate any complaint alleging a violation of this
- 11 chapter or a rule adopted under this chapter.
- 12 (b) A complaint must be filed in a manner prescribed by the
- 13 board.
- 14 Sec. 1306.202. ADMINISTRATIVE PENALTY. The board or
- 15 executive director may impose an administrative penalty on a person
- 16 under Subchapter F, Chapter 51, regardless of whether the person is
- 17 registered under this chapter, if the person violates:
- 18 (1) this chapter or a rule adopted under this chapter;
- 19 or
- 20 (2) an order of the board or executive director.
- 21 Sec. 1306.203. SANCTIONS. The board may impose sanctions
- 22 <u>as provided by Section 51.353.</u>
- 23 Sec. 1306.204. CEASE AND DESIST ORDER. The executive
- 24 director may issue a cease and desist order under Section 51.3513 to
- 25 prohibit any person from performing or engaging in a reroofing
- 26 project if the person is not in compliance with this chapter.
- Sec. 1306.205. CRIMINAL PENALTY. (a) A person commits an

- 1 offense if the person violates this chapter.
- 2 (b) An offense under this section is a Class C misdemeanor.
- 3 (c) If the conduct constituting an offense under this
- 4 section also constitutes an offense under Section 32.42(b)(12),
- 5 Penal Code, the person may be prosecuted under either section or
- 6 under both sections.
- 7 Sec. 1306.206. DECEPTIVE TRADE PRACTICE. A reroofing
- 8 contractor who advertises that the contractor holds a registration
- 9 under this chapter commits a false, misleading, or deceptive act or
- 10 practice within the meaning of Section 17.46, Business & Commerce
- 11 Code, if the reroofing contractor does not hold a valid
- 12 registration issued under this chapter.
- 13 SECTION 2. The Texas Board on Reroofing Contractors shall
- 14 adopt rules necessary to implement Chapter 1306, Occupations Code,
- 15 as added by this Act, not later than January 1, 2020. The Texas
- 16 Board on Reroofing Contractors shall begin issuing registrations
- 17 under Chapter 1306, Occupations Code, as added by this Act, not
- 18 later than March 1, 2020.
- 19 SECTION 3. (a) Except as provided by Subsection (b) of this
- 20 section, this Act takes effect September 1, 2019.
- 21 (b) Section 1306.101, Occupations Code, and Subchapters D
- 22 and E, Chapter 1306, Occupations Code, as added by this Act, take
- 23 effect March 1, 2020.
