- SECTION 11. Section 5.07, Chapter 824 (S.B. 817), Acts of the 73rd Legislature, Regular Session, 1993 (Article 62430, Vernon's Texas Civil Statutes), is amended by amending Subsection (b) and adding Subsection (b-1) to read as follows:
- 15 (b) Subject to Subsection (b-1) of this section, if [If] the 16 retiree received income from other employment, including 17 self-employment, during the preceding year, the board may reduce the retiree's disability retirement annuity by the amount of \$1 for 18 19 each month for each \$2 of income earned by the retiree from the other employment during each month of the previous year, except 20 that the disability retirement annuity may not be decreased below 21 the amount determined under Section 5.05(c) of this Act. 22
- 23 (b-1) The board may, in the board's sole discretion, restore
 24 a disability retirement annuity that has been reduced under
 25 Subsection (b) of this section. The amount of the restored annuity
 26 must be the same as the amount of the annuity before the reduction
 27 plus any applicable cost-of-living increases under Section 5.09 of

1 regard to the interest of the spouse or former spouse. 2 (3) "Eligible retirement plan" means: 3 (A) an individual retirement account described by Section 408(a) of the code; 4 5 (B) an individual retirement annuity described by Section 408(b) of the code; 6 7 (C) a qualified annuity plan described by Section 8 403(a) of the code; 9 (D) a qualified trust described by Section 401(a) 10 of the code; (E) an eligible deferred compensation plan 11 12 described by Section 457(b) of the code that is maintained by an eligible employer described by Section 457(e)(1)(A) of the code; 13 14 (F) an annuity contract described by Section 15 403(b) of the code that accepts the distributee's eligible rollover 16 distribution; or 17 (G) in the case of an eligible rollover distribution to a designated beneficiary who is not the surviving 18 19 spouse, or the spouse or former spouse under a qualified domestic relations order, an individual retirement account or individual 20 21 retirement annuity only. 22 (4) "Eligible rollover distribution" means distribution of all or any portion of the balance to the credit of 23 24 the distributee. The term does not include: (A) a distribution that is one of a series of 25 26 substantially equal periodic payments, paid not less frequently 27 than once a year, made over the life or life expectancy of the

- 1 distributee or the joint lives or joint life expectancies of the
- 2 distributee and the distributee's designated beneficiary;
- 3 (B) a series of payments for a specified period
- 4 of 10 years or more;
- 5 (C) a distribution to the extent the distribution

- 22 (j) Notwithstanding any other provision of this Act, the
- 23 limitations on benefits imposed by Section 415 of the code and
- 24 Subsection (a) of this section must be adjusted each year to the
- 25 extent permitted by cost-of-living increases announced by the
- 26 secretary of the treasury under Section 415(d) of the code and
- 27 applicable law. A cost-of-living increase described by this

- 1 subsection applies to members who have terminated employment,
- 2 including members who have begun receiving benefits before the
- 3 <u>effective date of the increase</u>, and any benefits previously denied.
- 4 Benefits paid to make up for benefits previously denied are
- 5 considered the delayed payment of benefits earned before retirement
- 6 and not extra compensation earned after retirement. [To the extent
- 7 permitted by law, the board may adjust the benefits of retired
- 8 members and beneficiaries by increasing any retirement benefit that
- 9 was reduced because of Section 415 of the code. If Section 415 of
- 10 the code is amended to permit the payment of amounts previously
- 11 precluded under Section 415 of the code, the board may adjust the
- 12 benefits of retired members and beneficiaries, including the
- 13 restoration of benefits previously denied. Benefits paid under
- 14 this subsection are not considered as extra compensation earned
- 15 after retirement but as the delayed payment of benefits earned
- 16 before retirement.
- 17 SECTION 13. Section 6.01(b), Chapter 824 (S.B. 817), Acts
- 18 of the 73rd Legislature, Regular Session, 1993 (Article 6243o,
- 19 Vernon's Texas Civil Statutes), is amended to read as follows:
- 20 (b) Subject to the applicable provisions of this Act,
- 21 <u>including Section 6.02(j) of this Act, a</u> [A] dependent child is
- 22 entitled to receive benefits based on the service of any parent who
- 23 is a member of the fund.
- 24 SECTION 14. Sections 6.02(d-2), (g), and (j), Chapter 824
- 25 (S.B. 817), Acts of the 73rd Legislature, Regular Session, 1993
- 26 (Article 62430, Vernon's Texas Civil Statutes), are amended to read
- 27 as follows:

(d-2) If, at the time a death benefit annuity becomes payable under Subsection (a) or (c) of this section, a [deceased member or] retiree leaves a surviving spouse who is not entitled to an annuity on the date of the retiree's death under Subsection (g-1) of this section as the result of Subsection (g-3) of this section and the deceased retiree has one or more dependent children, the dependent child or children shall be awarded 100 percent of the death benefit annuity until the annuity to the surviving spouse becomes payable [effective] under Subsection (g-3) of this section.

- A child who is adopted after the date of retirement of 10 (g) the member is not entitled to a death benefit annuity under this 11 12 Act. A child who is born after the date of retirement of the member is not entitled to a death benefit annuity under this Act unless the 13 14 retiree was married to the other parent of the child on the date of 15 retirement. A surviving spouse of a retiree whose status as a surviving spouse resulted from a marriage after the date of the 16 17 retirement of the retiree is entitled to receive only the benefits, if any, provided under Subsection (g-1) of this section or Section 18 6.08 of this Act. 19

- 6 Sec. 6.06. COMMON-LAW MARRIAGES. Common-law marriages are

SECTION 23. Section 3.03(a), Chapter 824 (S.B. 817), Acts 13 14 of the 73rd Legislature, Regular Session, 1993 (Article 62430, 15 Vernon's Texas Civil Statutes), is repealed.
