## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the prosecution and punishment of the offense of prostitution, to juvenile court referrals for conduct constituting 3 prostitution, and to a court cost imposed on conviction of certain 4 prostitution offenses. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 7 SECTION 1. Subchapter A, Chapter 102, Code of Criminal Procedure, is amended by adding Article 102.023 to read as follows: 8 Art. 102.023. COURT COSTS: COMMERCIAL SEXUAL EXPLOITATION 9 VICTIM FUND. (a) The commercial sexual exploitation victim fund is 10 11 a dedicated account in the general revenue fund. 12 (b) A person convicted of an offense under Section 43.02(b), Penal Code, shall pay as a cost of court \$500 on conviction of the 13 14 offense. 15 (c) For purposes of this article, a person is considered to 16 have been convicted if: (1) a sentence is imposed on the person; or 17 18 (2) the person receives community supervision, including deferred adjudication community supervision. 19 (d) Court costs under this article are collected in the same 20 21 manner as other fines or costs. An officer collecting the costs shall keep separate records of the funds collected as costs under 22 23 this article and shall deposit the funds in the county treasury. 24 (e) The custodian of a county treasury shall:

ADDITIONAL COURT COSTS ON CONVICTION: CODE OF CRIMINAL PROCEDURE. A person convicted of an offense shall pay, 4 in addition to all other costs, a court cost on conviction to 5 benefit victims of commercial sexual exploitation in this state 6 (Art. 102.023, Code of Criminal Procedure). . . \$500. 7 8 SECTION 3. Section 51.03, Family Code, is amended by amending Subsection (b) and adding Subsection (d) to read as 9 10 follows: Conduct indicating a need for supervision is: 11 (b) 12 (1)subject to Subsection (f), conduct, other than a traffic offense, that violates: 13 14 (A) the penal laws of this state of the grade of 15 misdemeanor that are punishable by fine only; or (B) the penal ordinances of any 16 political 17 subdivision of this state; (2) the voluntary absence of a child from the child's 18 19 home without the consent of the child's parent or guardian for a substantial length of time or without intent to return; 20 21 (3) conduct prohibited by city ordinance or by state law involving the inhalation of the fumes or vapors of paint and 22 other protective coatings or glue and other adhesives and the 23 24 volatile chemicals itemized in Section 485.001, Health and Safety Code; 25 26 (4) an act that violates a school district's previously communicated written standards of student conduct for 27

1 which the child has been expelled under Section 37.007(c), Education Code; 2 3 (5) notwithstanding Subsection (a)(1), conduct described by Section 43.02(b) [43.02(a) or (b)], Penal Code; or 4 5 (6) notwithstanding Subsection (a)(1), conduct that violates Section 43.261, Penal Code. 6 7 (d) Notwithstanding Subsection (a)(1), conduct that violates Section 43.02(a), Penal Code, is not delinquent conduct or 8 conduct indicating a need for supervision. A child may not be 9 10 referred to the juvenile court for conduct that violates Section 43.02(a), Penal Code. 11 SECTION 4. Section 43.02, Penal Code, is amended by adding 12 Subsection (b-1) and amending Subsection (c) to read as follows: 13 14 (b-1) A person may not be prosecuted for an offense under 15 Subsection (a) that the person committed when younger than 18 years of age. 16 (c) An offense under Subsection (a) is a Class  $\underline{C}$  [ $\underline{B}$ ] 17 misdemeanor, except that the offense is: 18 19 (1) a Class B [A] misdemeanor if the actor has previously been convicted one or two times of an offense under 20 Subsection (a); or 21 (2) a Class A misdemeanor [state jail felony] if the 22

23 actor has previously been convicted three or more times of an 24 offense under Subsection (a).

25 SECTION 5. (a) Article 102.023, Code of Criminal 26 Procedure, as added by this Act, applies only to a cost on 27 conviction for an offense committed on or after the effective date

of this Act. An offense committed before the effective date of this
 Act is governed by the law in effect on the date the offense was
 committed, and the former law is continued in effect for that
 purpose.

5 (b) Section 51.03, Family Code, and Section 43.02, Penal 6 Code, as amended by this Act, apply only to an offense committed or 7 conduct that occurs on or after the effective date of this Act. An 8 offense committed or conduct that occurs before the effective date 9 of this Act is governed by the law in effect on the date the offense 10 was committed or the conduct occurred, and the former law is 11 continued in effect for that purpose.

(c) For the purposes of this section, an offense was
committed or conduct occurred before the effective date of this Act
if any element of the offense or conduct occurred before that date.
SECTION 6. This Act takes effect September 1, 2019.
