- 10 metal dealer's license plates, including dealer specialty license

- 14 (2) for which the dealer has been issued a general

- 6 (1) metal dealer's license plates for use in

- 8 (2) personalized prestige dealer's plates for use in
- 9 accordance with Section 503.0615.
- 10 (b) The department shall issue not more than three specialty
- 11 license plate designs under this section. License plates issued
