H.B. No. 3247

A BILL TO BE ENTITLED

AN ACT

relating to the Texas Emergency Services Retirement System.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 861.001, Government Code, is amended by amending Subdivisions (4), (5), (8), (10), and (11-a) and adding Subdivisions (6-a), (6-b), (8-a), (8-b), and (10-a) to read as follows:

(4) "Dependent" means an unmarried child, natural or adopted, who:

(A) is less than 18 years of age;

(B) is less than 19 years of age and a full-time student at an elementary or secondary school; or

(C) became permanently disabled before the child's 22nd birthday, as determined by a local board [~~and remains disabled~~].

(5) "Emergency services" means only those services relating to fire, rescue, [~~and~~] emergency medical services, and emergency response services [~~including support services for those duties, performed by a volunteer or auxiliary employee of a participating department~~].

(6-a) "Governing body of a department" or "governing body of a participating department" means:

(A) the board of trustees or other governing body of the department; or

1 (B) if the department does not have a governing
2 body, the governing body of the political subdivision.

3 (6-b) "Governing body of a political subdivision"
4 means the governing body of the political subdivision or unit of
5 government of which the department is a part.

6 (8) "Member" means a person having membership
7 ~~[volunteer or auxiliary employee who participates]~~ in the pension
8 system.

9 (8-a) "Participating department" means a department
10 that elects to participate in the pension system under Section
11 [862.001](#).

12 (8-b) "Participating department head" means the
13 person designated as a participating department head under Section
14 [865.0115](#).

15 (10) "Qualified service" means service performed:

16 (A) for a participating department that ~~[is~~
17 ~~recognized as an emergency services department by its governing~~
18 ~~body and that]~~ conducts at least 48 hours of training in a calendar
19 year; and

20 (B) ~~[that is performed]~~ by a member in good
21 standing in the department who:

22 (i) attends at least 20 hours of annual
23 training and at least 25 percent of the department's emergencies in
24 a calendar year;

25 (ii) attends at least 20 hours of annual
26 training and provides support services for at least 25 percent of
27 the department's emergencies in a calendar year; or

1 (iii) does not attend because the member is
2 absent because of military duty.

3 (10-a) "Retiree" means a person who receives a service
4 or disability retirement benefit from the pension system.

5 (11-a) "Support services" means services that
6 directly assist in the delivery of emergency services. The term
7 includes:

8 (A) directing traffic at an emergency scene;

9 (B) [] dispatching emergency services
10 personnel;

11 (C) [] driving an emergency services vehicle;

12 (D) [] supplying or maintaining equipment at an
13 emergency scene;

14 (E) [] providing essential recordkeeping for a
15 participating department; [] and

16 (F) other similar services as determined by a
17 participating department.

18 SECTION 2. Section 861.008, Government Code, is amended to
19 read as follows:

20 Sec. 861.008. IMMUNITY FROM LIABILITY. The state board,
21 the executive director, a local board, each department head, and
22 employees of the pension system are not liable for any action taken
23 or omission made or suffered by them in good faith in the
24 performance of any duty or prerogative in connection with the
25 administration of the pension system.

26 SECTION 3. Section 862.001, Government Code, is amended to
27 read as follows:

1 Sec. 862.001. PARTICIPATION BY DEPARTMENT. (a) For
2 purposes of this section, "department" means a department or other
3 organization that:

4 (1) performs emergency services, including a
5 volunteer fire department, as defined by Section 614.101; and

6 (2) is not a for-profit entity.

7 (a-1) The governing body of a department [~~that performs~~
8 ~~emergency services~~] may, in the manner provided for taking official
9 action by the body, elect to participate in the pension system. The
10 [A] governing body of a department shall notify the executive
11 director as soon as practicable of an election made under this
12 subsection. Except as provided by Subsection (b), an election to
13 participate under this subsection is irrevocable.

14 (b) The state board may adopt rules that allow the governing
15 body of a participating department to revoke its [~~that makes an~~
16 election to participate in the pension system under Subsection
17 (a-1) in a manner that maintains an actuarially sound [~~(a) may~~
18 ~~terminate participation in the~~] pension system [~~not later than the~~
19 ~~fifth anniversary of the date of the election to participate,~~
20 ~~except that a department that begins participation after September~~
21 ~~1, 2005, may not terminate that participation~~].

22 SECTION 4. Section 862.002, Government Code, is amended to
23 read as follows:

24 Sec. 862.002. MEMBERSHIP BY INDIVIDUAL. (a) Except as
25 otherwise provided by this section and Section 862.0021, each
26 person who performs emergency services or, subject to Section
27 862.0025, support services [~~service~~] as a volunteer or [~~auxiliary~~]

1 employee of a participating department, regardless of whether the
2 person receives compensation from the participating department for
3 the services, is a member of the pension system.

4 (b) A person is not a member of the pension system if the
5 person:

6 (1) is less than 18 years of age;

7 (2) is subject to ~~[in]~~ a waiting ~~[probationary]~~ period
8 under Section 862.0021 ~~[of service before becoming a regular member~~
9 ~~of a participating department]~~ for which the participating
10 department is not making contributions for the training or service;

11 (3) does not receive a certification of physical
12 fitness or assignment to perform support services under Section
13 862.003; or

14 (4) is a retiree ~~[retired under this subtitle]~~,
15 regardless of whether the person continues to perform emergency or
16 support services ~~[participate in emergency service-related~~
17 ~~functions]~~ for a department ~~[from which the person retired]~~.

18 SECTION 5. Section 862.0021, Government Code, is amended to
19 read as follows:

20 Sec. 862.0021. WAITING ~~[PROBATIONARY]~~ PERIOD BEFORE
21 MEMBERSHIP. (a) A participating department may impose a waiting
22 ~~[probationary]~~ period for a person who begins performing, or
23 training to perform, emergency services or, subject to Section
24 862.0025, support services as a volunteer or ~~[auxiliary]~~ employee
25 of the department during which time the department is not required
26 to enroll the person as a member of the pension system.

27 (b) A waiting ~~[probationary]~~ period imposed under this

1 section must end not later than six months after the date the person
2 begins service or training with the participating department.

3 (c) The governing body of a participating department may,
4 but is not required to pay contributions for the person during the
5 waiting [~~probationary~~] period.

6 (d) A person's membership in the pension system begins on
7 the date that the governing body of a participating department
8 begins payment of contributions for that person, without regard to
9 whether the:

10 (1) person's membership in the pension system
11 [~~service~~] is subject to a waiting [~~probationary~~] period under this
12 section; or

13 (2) person is subject to a probationary period imposed
14 by a participating department for other purposes.

15 SECTION 6. Sections 862.0025(a) and (c), Government Code,
16 are amended to read as follows:

17 (a) Except as provided by Subsection (b), the governing body
18 of a participating department may, at any time, make an election to
19 include all persons who provide support services for the department
20 as members of the pension system [~~on the same terms as all other~~
21 ~~volunteers of the department~~]. An election under this section
22 takes effect on the first day of the calendar month that begins
23 after the month in which the election is made and communicated to
24 the executive director. Once made, an election under this section
25 is irrevocable.

26 (c) After an election under this section, a participating
27 department that previously did not enroll its support staff as

1 members of the pension system may purchase service credit for
2 service performed before the date of the election under the terms
3 required for prior service credit for service before departmental
4 participation under Section 863.004.

5 SECTION 7. Section 862.003, Government Code, is amended to
6 read as follows:

7 Sec. 862.003. CERTIFICATION OF PHYSICAL FITNESS. (a) A
8 person who performs emergency services for a participating
9 department [~~prospective member~~] shall present to the participating
10 department [~~local~~] head [~~of the department, for delivery to the~~
11 ~~local board,~~] a certification of physical fitness by a qualified
12 physician. [~~The person becomes a member of the pension system if~~
13 ~~the local board accepts the certification or if the local board~~
14 ~~assigns the person to perform support services and enrolls its~~
15 ~~support staff as members of the system.~~]

16 (b) If a participating department provides membership to a
17 person who performs support services under Section 862.0025, the
18 participating department head [~~A local board~~] shall assign a person
19 to perform support services if the person:

20 (1) does not present an acceptable certification under
21 Subsection (a); or

22 (2) will only perform support services for the
23 department [~~and the person is at least 18 years of age, is not~~
24 ~~retired from the pension system, and is not serving a probationary~~
25 ~~period before becoming a regular member of a participating~~
26 ~~department~~].

27 SECTION 8. Section 863.003, Government Code, is amended to

1 read as follows:

2 Sec. 863.003. RECOGNITION [~~TRANSFER~~] OF PRIOR SERVICE
3 CREDIT. A member who terminates service, except by service
4 retirement under Chapter 864, and later resumes service with the
5 same participating department or begins service with another
6 participating department may receive service credit for [~~transfer~~]
7 all previously accrued service credit in the pension system earned
8 for service with any participating [~~to the new~~] department.

9 SECTION 9. Chapter 863, Government Code, is amended by
10 adding Section 863.0045 to read as follows:

11 Sec. 863.0045. SERVICE CREDIT AND MEMBERSHIP IN MULTIPLE
12 PUBLIC RETIREMENT SYSTEMS. In accordance with Section 67(a)(2),
13 Article XVI, Texas Constitution, a person may not earn service
14 credit for the same service with the pension system and another
15 public retirement system.

16 SECTION 10. Section 863.005, Government Code, is amended to
17 read as follows:

18 Sec. 863.005. CHARGE FOR CERTAIN PAST DUE CONTRIBUTIONS.
19 The state board by rule may impose an interest charge on
20 contributions due because of a correction of an error [~~by a local~~
21 ~~board~~] related to enrollment or qualified service. The charge must
22 be based on the pension system's current assumed rate of return.
23 Charges collected shall be deposited in the fund.

24 SECTION 11. Section 864.001(b), Government Code, is amended
25 to read as follows:

26 (b) The state board may change the benefit formula for any
27 person who is not a retiree [~~an annuitant~~] of the pension system.

1 SECTION 12. Section 864.002(a), Government Code, is amended
2 to read as follows:

3 (a) A service retirement annuity is payable in monthly
4 installments based on:

5 (1) the [~~governing body's~~] average monthly
6 contribution during the member's term of qualified service with all
7 participating departments under this subtitle, not including a
8 contribution to reduce the unfunded accrued actuarial liability of
9 the pension system; and

10 (2) a formula adopted by the state board by rule that
11 allows the pension system, assuming maximum state contributions are
12 provided under Section 865.015, to be maintained as actuarially
13 sound.

14 SECTION 13. Section 864.004, Government Code, is amended to
15 read as follows:

16 Sec. 864.004. TEMPORARY DISABILITY RETIREMENT BENEFITS.

17 (a) A member is entitled to disability retirement benefits from the
18 pension system only if a local board determines that the member
19 became disabled during the performance of emergency services or
20 support services [~~service duties~~] and is unable to return to work at
21 the member's regular occupation or, if the member is a student, is
22 unable to return to the member's scholastic studies. A disabled
23 member must, at the time of disability, elect between a service
24 retirement annuity or disability retirement benefits, if eligible
25 for both.

26 (b) Subject to Subsection (c), a [~~A disabled~~] member
27 described by Subsection (a) who does not elect to receive a service

1 retirement annuity is entitled to a temporary disability retirement
2 benefit [~~benefits~~] of:

3 (1) \$300 per [~~a~~] month; or

4 (2) a greater amount that the state board by rule
5 adopts based on the monthly contributions made for the members by
6 [~~of~~] a participating department [~~for its members~~].

7 (c) Except as provided by Section 864.005, a temporary [~~To~~
8 ~~continue to receive~~] disability retirement benefit under [~~benefits~~
9 ~~in the form of a continuing annuity, computed in the manner~~
10 ~~described by~~] Subsection (b) must cease on the expiration of a
11 period, not to exceed one year, determined to be the likely duration
12 of the disability by a physician in a written statement to the
13 pension board. The local board shall select the physician making a
14 determination under this subsection [~~, a person who is determined by~~
15 ~~a local board to be temporarily disabled must:~~

16 [~~(1) apply to the medical board appointed by the state~~
17 ~~board, and~~

18 [~~(2) not later than the first anniversary of the date~~
19 ~~the person was determined to be temporarily disabled, be certified~~
20 ~~by the medical board as permanently disabled for the performance of~~
21 ~~the duties of the person's regular occupation].~~

22 SECTION 14. Sections 864.005(a), (b), (d), and (h),
23 Government Code, are amended to read as follows:

24 (a) A local board may [~~shall~~] require a member who is
25 receiving a temporary disability retirement benefit [~~benefits~~] to
26 file a disability rating report every three months from a physician
27 chosen by the local board. If a report indicates a significant

1 improvement in condition, the local board, after notice and a
2 hearing, may adopt an order to terminate temporary disability
3 retirement benefit payments. The local board shall send a copy of
4 each order adopted under this subsection to the executive director.

5 (b) Temporary disability benefits cease if:

6 (1) the recipient returns to work at the person's
7 regular occupation, resumes scholastic studies, or performs
8 emergency services or support services [~~service duties~~] for any
9 participating department or other entity; or

10 (2) [~~agency, or if~~] the local board adopts an order
11 under Subsection (d).

12 (d) If the local board has reason to believe that a ground
13 for termination of temporary disability retirement benefits
14 exists, the local board may set a date for a hearing on the matter.
15 The local board, after notice and a hearing, may adopt an order
16 terminating temporary disability retirement benefits if the local
17 board determines that a ground for termination exists. The local
18 board may not adopt an order under this subsection on the basis of a
19 physician's previously submitted statement as to the likely
20 duration of the disability if the local board determines, after a
21 hearing, that the disability continues. The local board shall send
22 a copy of each order adopted under this subsection to the executive
23 director.

24 (h) A [~~The state board or a~~] local board may require
25 financial information from a person as a condition to the continued
26 receipt of temporary disability retirement benefits, including
27 federal income tax returns and wage earning forms. Failure to

1 timely provide requested information is a ground for terminating
2 benefits.

3 SECTION 15. Chapter 864, Government Code, is amended by
4 adding Section 864.0051 to read as follows:

5 Sec. 864.0051. CONTINUING DISABILITY RETIREMENT BENEFITS.

6 (a) To receive disability retirement benefits in the form of a
7 continuing annuity provided beyond the time prescribed under
8 Section 864.005, a person who has been determined by a local board
9 to be temporarily disabled must:

10 (1) not later than the first anniversary of the date
11 the person was determined to be temporarily disabled, apply to the
12 medical board designated under Section 865.020 in the manner and
13 form prescribed by the medical board; and

14 (2) be certified by the medical board as permanently
15 disabled for the performance of the duties of any occupation:

16 (A) for which the person is reasonably suited by
17 education, training, and experience; and

18 (B) that could reasonably be expected to provide
19 the person with at least 75 percent of the salary the person was
20 earning at the time the disability occurred.

21 (b) The amount of a continuing disability retirement
22 annuity under this section is determined in the same manner as for a
23 temporary disability retirement benefit under Section 864.004(b).

24 (c) Except as otherwise provided by this section, a
25 continuing disability retirement annuity terminates on the fifth
26 anniversary of the date that payment of the continuing disability
27 retirement annuity begins following the certification of the

1 continuation of the disability under Subsection (a).

2 (d) To continue receiving payments of a continuing
3 disability retirement annuity after the fifth anniversary, the
4 retiree must be recertified as permanently disabled by the medical
5 board every five years using the same standard prescribed by
6 Subsection (a)(2).

7 (e) Payments of a continuing disability retirement annuity
8 to a retiree certified by the medical board as permanently disabled
9 under Subsection (a) or (d) shall cease if the retiree:

10 (1) returns to work at any occupation that provides
11 the person with at least 75 percent of the salary the person was
12 earning at the time the disability occurred;

13 (2) performs emergency services or support services
14 for any participating department; or

15 (3) rejects a suitable offer of employment, as
16 determined by the local board.

17 (f) If the state board has reason to believe that a ground
18 for termination of a continuing disability retirement annuity
19 exists, the state board shall set a date for a hearing on the
20 continuation or termination of the annuity. If the state board
21 determines that a ground for termination exists, the state board,
22 after notice and a hearing, shall adopt an order terminating the
23 continuing disability retirement annuity.

24 (g) The state board may require financial information,
25 including federal income tax returns and wage earning forms, from a
26 retiree as a condition of the continued receipt of continuing
27 disability retirement benefits. Failure to timely provide

1 requested information is a ground for terminating benefits.

2 SECTION 16. Section 864.006, Government Code, is amended to
3 read as follows:

4 Sec. 864.006. MEMBER SERVICE DEATH BENEFITS. (a) The
5 surviving spouse and dependents of a member who dies as a result of
6 performing emergency services or support services [~~service duties~~]
7 are entitled to receive in equal shares a death benefit annuity
8 equal to the service retirement annuity that the decedent would
9 have been entitled to receive if the decedent had been able to
10 retire, vested at 100 percent, on the date of the decedent's death.

11 (b) The beneficiary of a member who dies as a result of
12 performing emergency services or support services [~~service duties~~]
13 is entitled to a lump-sum benefit of \$5,000 or a greater amount that
14 the state board provides by rule.

15 SECTION 17. Sections 864.007(a) and (b), Government Code,
16 are amended to read as follows:

17 (a) The state board by rule may provide one or more
18 beneficiaries of a deceased member whose death did not result from
19 the performance of emergency services or support services [~~service
20 duties~~] a benefit, which may be a lump-sum amount or an annuity.

21 (b) A rule adopted under this section must include the type
22 of eligible recipient of the benefit, including any service or age
23 requirement, and the method of calculating the amount of the
24 benefit. A rule may include any other terms the state board
25 considers appropriate.

26 SECTION 18. Section 864.010, Government Code, is amended to
27 read as follows:

1 Sec. 864.010. BENEFITS FOR MEMBERS AND RETIREES OF
2 DEPARTMENT THAT WITHDRAWS FROM PARTICIPATION OR CEASES TO EXIST.

3 (a) The executive director shall continue to administer benefits
4 of the pension system for members and retirees who performed
5 emergency services or support services [~~perform service~~] for a
6 formerly participating department that has withdrawn from
7 participation in the pension system or has ceased to exist.

8 (b) The governing body of a political subdivision [~~in which~~
9 ~~a department described by Subsection (a) is or was located~~] shall
10 perform the duties required of a local board for the members and
11 retirees who served for the formerly participating department. The
12 state board may by rule:

13 (1) provide a procedure under which the governing body
14 of a department may delegate its duties under this subsection to the
15 executive director; or

16 (2) appoint the executive director to perform the
17 duties of a governing body of a political subdivision if the
18 governing body fails to perform or delegate its duties under this
19 subsection within a prescribed period of time.

20 SECTION 19. Section 864.011, Government Code, is amended to
21 read as follows:

22 Sec. 864.011. FIRST PAYMENT OF RETIREMENT OR DEATH BENEFIT
23 ANNUITY. The cashing or depositing of the first payment of a
24 service retirement annuity, disability retirement annuity, or
25 death benefit annuity by a person entitled to it, or the receipt by
26 a financial institution for credit to that person's account of a
27 transfer of funds by the pension system through electronic means,

1 is considered acceptance of the amount of the annuity and of the
2 amount of qualified service of the person on whose service the
3 annuity is based.

4 SECTION 20. Section 864.013, Government Code, is amended to
5 read as follows:

6 Sec. 864.013. COST-OF-LIVING INCREASE. The state board by
7 rule may provide a cost-of-living increase for any benefit provided
8 by the pension system. If benefits are increased, the state board
9 shall require an increase in monthly [~~governing body~~] contributions
10 if necessary to maintain an actuarially sound pension system.

11 SECTION 21. Section 864.0135, Government Code, is amended
12 to read as follows:

13 Sec. 864.0135. OPTIONAL ANNUITY INCREASE OR SUPPLEMENTAL
14 PAYMENTS. (a) The state board by rule may authorize the governing
15 body of a participating department to:

16 (1) make one or more supplemental payments to its
17 retirees and [~~other~~] beneficiaries of the pension system; or

18 (2) provide an increase in the amount of annuities
19 paid to retirees and [~~other~~] beneficiaries of the pension system.

20 (b) The governing body of a [A] participating department
21 that elects an option under a rule adopted under this section shall
22 fund all increased benefits that are provided to its retirees and
23 [~~other~~] beneficiaries of the pension system [~~department~~] under the
24 option.

25 SECTION 22. The heading to Section 864.015, Government
26 Code, is amended to read as follows:

27 Sec. 864.015. BENEFICIARY CAUSING DEATH OF MEMBER OR

1 RETIREE [~~ANNUITANT~~].

2 SECTION 23. Sections 864.015(a), (b), and (d), Government
3 Code, are amended to read as follows:

4 (a) A benefit payable on the death of a member or retiree
5 [~~annuitant~~] may not be paid to a person convicted of causing that
6 death but instead is payable as if the convicted person had
7 predeceased the decedent.

8 (b) The pension system is not required to change the
9 recipient of benefits under this section unless it receives actual
10 notice of the conviction of a beneficiary. The system may delay
11 payment of a benefit payable on the death of a member or retiree
12 [~~annuitant~~] pending the results of a criminal investigation and of
13 legal proceedings relating to the cause of death.

14 (d) For the purposes of this section, a person has been
15 convicted of causing the death of a member or retiree [~~annuitant~~] if
16 the person:

17 (1) pleads guilty or nolo contendere to, or is found
18 guilty by a court of, an offense at the trial of which it is
19 established that the person's intentional, knowing, or reckless act
20 or omission resulted in the death of a person who was a member or
21 retiree [~~annuitant~~], regardless of whether sentence is imposed or
22 probated; and

23 (2) has no appeal of the conviction pending and the
24 time provided for appeal has expired.

25 SECTION 24. Section 864.016, Government Code, is amended by
26 amending Subsections (a), (b), (c), (d), and (e) and adding
27 Subsection (a-1) to read as follows:

1 (a) An application [~~A claim~~] for disability retirement
2 benefits or a [~~lump-sum~~] death benefit must be filed with the local
3 board. [~~A claim for service retirement benefits must be filed with~~
4 ~~the executive director, who shall forward the claim to the~~
5 ~~appropriate local board for a hearing. A claim for a death benefit~~
6 ~~annuity must be filed with the executive director. The executive~~
7 ~~director shall make a determination of the merits of the claim for a~~
8 ~~death benefit annuity and issue a decision to the claimant.] On
9 receiving an application [~~a claim~~] under this subsection [~~section~~],
10 the local board shall hold a hearing to decide the merits of the
11 application and whether to approve or deny the application [~~claim~~].
12 The local board shall send a written copy of its decision to the
13 claimant, [~~and~~] the applicant, and the executive director. [~~If a~~
14 ~~local board does not determine a claim for service retirement~~
15 ~~benefits and file its determination with the executive director~~
16 ~~before the 16th day after the date the local board receives the~~
17 ~~claim, the executive director may determine the merits of the~~
18 ~~claim.]~~~~

19 (a-1) A claim for a service retirement annuity must be filed
20 with the executive director.

21 (b) A person aggrieved by a decision of a local board or of
22 the executive director relating to eligibility for or the amount of
23 benefits under this subtitle may appeal the decision to the state
24 board.

25 (c) An appeal of a local board or executive director
26 decision under this section is begun by delivering a notice of
27 appeal to the presiding officer or secretary of the local board that

1 made the decision or to the executive director, as applicable. The
2 notice must be delivered not later than the 20th day after the date
3 of the decision and contain a brief description of the reasons for
4 the appeal. The aggrieved person must file a copy of the notice
5 with the state board.

6 (d) An appeal of a local board or executive director
7 decision under this section is held in Austin and is a contested
8 case under Chapter 2001, conducted as a de novo hearing by the State
9 Office of Administrative Hearings.

10 (e) After a hearing under Subsection (d), the state board
11 shall decide each appeal from a local board or executive director
12 decision, issue a written opinion, and notify the local board or
13 executive director, as applicable, and the claimant if the state
14 board overrules the [~~local board's~~] decision.

15 SECTION 25. Section 865.001, Government Code, is amended by
16 amending Subsection (b) and adding Subsection (b-1) to read as
17 follows:

18 (b) Except as provided by Subsection (b-1), at [At] least
19 five trustees must be active members of the pension system, one of
20 whom must represent emergency medical services personnel.

21 (b-1) If there are no participating departments in the
22 pension system that provide emergency medical services, the
23 governor is not required to appoint a trustee to represent
24 emergency medical services personnel.

25 SECTION 26. Section 865.006, Government Code, is amended by
26 amending Subsection (a) and adding Subsection (d) to read as
27 follows:

1 (a) The state board shall employ a certified public
2 accountant, an actuary, and an investment consultant for the fund
3 and may acquire computer, custodial, or investment management
4 services for the fund. The costs of accounting, actuarial,
5 investment consulting, computer, custodial, or investment
6 management services and other administrative expenses may be paid
7 from income earned by investment of the fund. No portion of the
8 corpus or income of the fund may be used for purposes other than the
9 benefit of members, retirees [~~retired emergency services~~
10 ~~personnel~~], and their beneficiaries.

11 (d) The state board is responsible for seeking and
12 recovering any benefits fraudulently acquired from the pension
13 system. If the state board suspects fraud has occurred, the state
14 board shall notify the appropriate local board and the benefit
15 recipient and hold a hearing to determine whether fraud has
16 occurred. If, after the hearing, the state board determines that
17 benefits from the pension system have been or are being
18 fraudulently acquired, the state board shall seek appropriate
19 relief.

23 behalf of the pension system gifts of money or other property from

20 and may not be disclosed in a form identifiable with a specific
21 individual unless:

22 (1) the information is disclosed to:

23 (A) the individual or the individual's attorney,
24 guardian, executor, administrator, conservator, or other person
25 who the executive director determines is acting in the interest of
26 the individual or the individual's estate;

27 (B) a spouse or former spouse of the individual

1 after the executive director determines that the information is
2 relevant to the spouse's or former spouse's interest in member
3 accounts, benefits, or other amounts payable by the pension system;

10 (2) the information is disclosed under a subpoena and
11 the executive director determines that the individual will have a
12 reasonable opportunity to contest the subpoena.

13 (d) A determination and disclosure under Subsection (a) may
14 be made without notice to the individual member, retiree
15 [~~annuitant~~], or beneficiary.

16 SECTION 38. The following provisions of the Government Code
17 are repealed:

- 20 (3) Sections 864.005(c), (e), (f), and (g); and
- 21 (4) Section 865.010(d).

22 SECTION 39. Section 864.005, Government Code, as amended by
23 this Act, and Section 864.0051, Government Code, as added by this
24 Act, apply only to a claim for a disability retirement benefit that
25 is filed on or after the effective date of this Act. A claim for a
26 disability retirement benefit that is filed before the effective
27 date of this Act is governed by the law in effect immediately before

1 the effective date of this Act, and the former law is continued in
2 effect for that purpose.

3 SECTION 40. Section 864.016, Government Code, as amended by
4 this Act, applies only to an application for a disability
5 retirement or death benefit that is filed on or after the effective
6 date of this Act. A claim for a disability retirement or death
7 benefit that is filed before the effective date of this Act is
8 governed by the law in effect immediately before the effective date
9 of this Act, and the former law is continued in effect for that
10 purpose.

11 SECTION 41. This Act takes effect September 1, 2019.
