9 SECTION 2. Section 247.025, Health and Safety Code, is 10 amended to read as follows:

11 Sec. 247.025. ADOPTION OF RULES. <u>(a)</u> The executive 12 commissioner shall adopt rules necessary to implement this chapter, 13 including requirements for the issuance, renewal, denial, 14 suspension, and revocation of a license to operate an assisted 15 living facility.

(b) The executive commissioner shall adopt rules
 distinguishing and providing guidelines on the scope of services
 that an assisted living facility may provide under this chapter.

SECTION 3. As soon as practicable after the effective date of this Act:

(1) the Texas Board of Nursing shall adopt the rules necessary to implement Section 247.002(1), Health and Safety Code, as amended by this Act; and

(2) the executive commissioner of the Health and Human
Services Commission shall adopt the rules required by Section
247.025, Health and Safety Code, as amended by this Act.
