## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the civil liability of certain persons providing
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 79.003, Civil Practice and Remedies
- 6 Code, is amended to read as follows:
- 7 Sec. 79.003. DISASTER ASSISTANCE. (a) Except in a case of
- 8 reckless conduct or intentional, wilful, or wanton misconduct, a
- 9 person is immune from civil liability for an act or omission that
- 10 occurs in giving care, assistance, or advice with respect to the
- 11 management of an incident:

disaster assistance.

- 12 (1) that is a man-made or natural disaster that
- 13 endangers or threatens to endanger individuals, property, or the
- 14 environment, including a major disaster declared by the president
- 15 of the United States or a disaster declared under Section 418.014,
- 16 Government Code; and
- 17 (2) in which the care, assistance, or advice is
- 18 provided at the request of  $\underline{\cdot}$
- 19 <u>(A)</u> an authorized representative of a local,
- 20 state, or federal agency, including a fire department, <u>a</u> police
- 21 department, an emergency management agency, and a disaster response
- 22 agency; or

- 23 <u>(B) a charitable organization, as that term is</u>
- 24 defined by Section 84.003, that provides services to mitigate the

- 1 effects of a disaster described by Subdivision (1).
- 2 (b) <u>Subsection (a)</u> [This section] does not apply to a person
- 3 giving care, assistance, or advice for or in expectation of
- 4 compensation from or on behalf of the recipient of the care,
- 5 assistance, or advice in excess of reimbursement for expenses
- 6 incurred.
- 7 (c) Notwithstanding Chapter 101 or any other law, an entity
- 8 and the authorized representative of the entity are not liable
- 9 under the laws of this state for the act or omission of a person
- 10 providing care, assistance, or advice on request under Subsection
- 11 (a)(2)(A).
- 12 (d) Notwithstanding Chapter 84 or any other law, a
- 13 charitable organization is not liable under the laws of this state
- 14 for the act or omission of a person providing care, assistance, or
- advice on request under Subsection (a)(2)(B).
- 16 <u>(e) The immunities provided by this section are in addition</u>
- 17 to any other immunity or limitations of liability provided by law,
- 18 including Subchapter D, Chapter 74, this chapter, or Chapter 78 or
- 19 78A of this code or Section 418.006, Government Code.
- 20 SECTION 2. Section 79.003, Civil Practice and Remedies
- 21 Code, as amended by this Act, applies only to a cause of action that
- 22 accrues on or after the effective date of this Act.
- 23 SECTION 3. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect September 1, 2019.
