A BILL TO BE ENTITLED AN ACT

1-19 relating to the civil liability of certain persons providing 1-20 disaster assistance. 1-21

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 1-23 SECTION 1. Section 79.003, Civil Practice and Remedies Code, is amended to read as follows:

Sec. 79.003. DISASTER ASSISTANCE. (a) Except in a case of 1-24 reckless conduct or intentional, wilful, or wanton misconduct, a person is immune from civil liability for an act or omission that 1-25 1-26 occurs in giving care, assistance, or advice with respect to the 1-27 1-28 management of an incident:

1-29 (1) that is a man-made or natural disaster that endangers or threatens to endanger individuals, property, or the 1-30 environment, including a major disaster declared by the president of the United States or a disaster declared under Section 418.014, Government Code; and 1-31 1-32 1-33

1-34 (2) in which the care, assistance, or advice is 1-35 provided at the request of:

1-36 (A) an authorized representative of a local, state, or federal agency, including a fire department, a police department, an emergency management agency, and a disaster response 1-37 1-38 1-39 agency; or

H.B. No. 3365 Code, as amended by this Act, applies only to a cause of action that accrues on or after the effective date of this Act. SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.
